Local Government Efficiency Awards

Department of State

The New York State Department of State is announcing the availability of this incentive awards program to provide grants to entities that achieve cost savings and local service delivery efficiencies through municipal consolidation or intermunicipal cooperative efforts. These non-competitive grants are intended to provide funding for cooperative efforts by entities which achieve savings through the sharing of services. Applications are being requested from eligible municipalities to cover the costs associated with plans and studies for functional consolidation and increased shared services. State reimbursements will be made for up to 90 percent of the actual cost of a Local Government Efficiency Grant proposal or the maximum amount permitted per municipality, whichever is less. The Housing Trust Fund Corporation reserves the right to award all, a portion of, or none of the program funds based upon funding availability, the feasibility of the applications received, the competitiveness of the applications and the applicant's ability to meet Housing Trust Fund Corporation criteria for funding.

ELIGIBILITY: Municipalities, regional planning and development boards, school districts and BOCES.

FUNDING: Up to \$2 million has been allocated to high priority planning grants with individual awards of up to \$50,000 available. **DEADLINE:** Applications will be evaluated on a rolling basis with the next deadline occurring on December 10, 2008, and the following occurring on January 14, 2009.

Housing Trust Fund Corporation

The Housing Trust Fund Corporation has announced a grant program under the Housing Trust Fund Program, the New York State HOME Program, the Urban Initiatives Program, and the Rural Area Revitalization Projects Program. This grant will be available to eligible municipalities for costs associated with projects that promote large-scale, transformative change in municipalities and that can be used as living laboratories for municipal innovation. Projects may include the consolidation of supporting services for school districts within an area served by a BOCES, consolidation of multiple police forces or multiple fire districts, fire departments or fire companies, creation of a regional smart growth compact or program, consolidation of services on a multi-county basis, or the creation of a regional or citycounty consolidated municipal government.

ELIGIBILITY: Municipalities, regional planning and development boards, school districts and BOCES.

FUNDING: Project grants will not to exceed \$400,000 per municipality and award amounts vary by project type.

AmeriCorps State and National Grants

Corporation for National and Community Service

For more than a decade, the Corporation for National and Community Servicethrough its Senior Corps, AmeriCorps, and Learn and Serve America programs—has mobilized a new generation of engaged

citizens. This year, more than 1.8 million individuals of all ages and backgrounds will serve through these programs. They will help thousands of national and community non-profit organizations, faith-based groups, schools, and local agencies meet local needs in education, the environment, public safety, homeland security, and other critical areas. AmeriCorps grants are awarded to eligible organizations to recruit, train, and manage AmeriCorps members who address community needs. An AmeriCorps member is an individual who is enrolled in an approved national service position and engages in community service. Members may receive a living allowance and other benefits while serving. Upon successful completion of their service members receive an education award from the National Service Trust. Roughly three-quarters of all AmeriCorps grant funding goes to Governorappointed state service commissions, which award subgrants to organizations in their states. These organizations recruit AmeriCorps members to respond to local needs. The Corporation distributes most of the remainder of the grant funding directly to organizations operating in more than one state.

ELIGIBILITY: Eligible applicants include public or private not-for-profit organizations, including labor organizations; faith-based and other community organizations; institutions of higher education; government
