I hope you are looking forward to the sunny days of summer and taking advantage of our beautiful white sand beaches and wonderful state parks.

This year's legislative session in Albany was one of the most productive in history. We addressed the issues that New Yorkers demanded we tackle, and the results will be overwhelmingly positive for the people of Northeastern Queens.

This March, I helped pass an on-time New York State budget. We closed the state's \$3.5 billion deficit, restored critical funding for education and health care, and funded important job-creation and infrastructure programs. The budget continued the lowest middle-class tax rate in 58 years, which cut taxes for 99 percent of New Yorkers in December.

My Assembly colleagues and I also passed an important package of bills to end pay inequity and demand equal pay for women.

This year, the legislature redefined district lines throughout New York State – reshaping the 24<sup>th</sup> Assembly District. I voted against the new maps put forward by the Task Force on Demographic Research and Reapportionment (LATFOR) as I felt the maps failed to keep communities of interest together. I continued to call for the appointment of an independent redistricting commission. Now that the new lines have been approved, I look forward to continuing to serve as your Assemblyman in the 24<sup>th</sup> Assembly district and to welcome new communities to our district.

Thank you for your continued support and activism. My staff and I continue to receive your letters, calls, visits, and emails with great enthusiasm and work diligently to address your concerns. **Dream Act**

#### **Beacon Program**

The Beacon program at MS 158 provides free afterschool services to elementary, middle school, and high school students throughout our community – yet this year, the city has proposed to close the door of the MS 158 Beacon Program and 6 other Beacon programs.

Assemblymember David I. Weprin wrote a letter to Mayor Bloomberg and attended several rallies to denounce the proposed closure of this and other Beacon programs throughout New York City.

"Beacon programs provide vital services for children and their families," wrote Assemblymember Weprin. "Cuts to these programs will have detrimental effects on the children and families that rely on them for a safe and supportive place to go after school."

Early Intervention programs help children under the age of 3 who have been diagnosed with a disability or developmental delay get the care they need. Early intervention makes a world of difference for the children who receive treatment. Beginning therapies like speech pathology and physical therapy early on in the lives of these children can help improve their quality of life for a lifetime. The counseling and social services support helps families understand what's happening with their children and prepares them for what to expect in the future.

Recognizing the importance of this program, The New York State Assembly unanimously passed Assemblyman Weprin's resolution to recognize March 1 as New York State Early Intervention Day and fought to ensure that vital Early Intervention funding was protected in the budget.

#### Working to Protect Consumers at the Pump

With the cost of oil on the rise, serious competition between gas distributors has caused many stations to charge outrageous amounts for a gallon of gasoline. In fact, some gas merchants have been known to continuously raise their prices over the course of a 24-hour period, often dramatically increasing consumer costs without the actual price of gas going up. This predatory practice, known as price gouging, allows a deceitful gas distributor to make unreasonable profits at a time when many families are struggling to make ends meet.

As gas prices constantly fluctuate, we must make sure our families don't fall victim to price gouging at the pumps. That's why the Assembly passed legislation, co-sponsored by Assemblymember Weprin, that would ban gas stations from adjusting their prices multiple times daily (A.1970) and allow victims to directly sue price gougers (A.8340).

Assemblyman Weprin also introduced legislation to require all gas stations in the State of New York to post a sign near each gas pump that lists contact information for the NYS Consumer Protection Board, which is authorized to investigate such complaints and take action against violators.

### **Lowering Co-pays for Seniors**

Assemblymember Weprin recognizes the need to ensure our seniors are getting the medicine they need in an affordable way. This year, the state budget restored \$30.6 million to the Elderly Pharmaceutical Insurance Coverage (EPIC) program – helping reinstate copayment assistance for approximately 300,000 EPIC enrollees. Currently, seniors enrolled in the EPIC program are forced to pay 25 percent of the cost of each prescription drug. With the co-payment assistance restored, enrollees will return to paying no more than \$20 co-payment for each prescription.



#### **Alice's Law**

Assemblyman David Weprin has been working to pass a law that would protect New Yorkers against criminals who intentionally crash vehicles into the cars of unsuspecting drivers as a way to fraudulently collect insurance money. A loophole in New York State's no-fault insurance laws has led to a dramatic increase in the number of these staged accidents -- creating a cottage industry of auto fraud. The Assemblyman's bill, "Alice's Law," would make staged accidents a stand-alone crime. The bill has already passed the Senate.
