### Beware of Hurricane Charity Scammers, N.Y. Officials Warn

As Texas, Florida, and Puerto Rico clean up after hurricanes, swindlers have been posing as legitimate charity organizations to steal money

A state legislator for Manhattan's Upper East Side issued a public warning Wednesday: Watch out for hurricane-relief scammers.

As Texas, Florida, and Puerto Rico clean up after damaging hurricanes, swindlers have been posing as legitimate charity organizations to steal money from the unsuspecting, said **New York State Assembly Member Rebecca Seawright, chair of the assembly's Subcommittee on Consumer Fraud Protection.**

Beware of fake charities soliciting help for Puerto Rico NEW YORK (WABC) --The devastation in Puerto Rico has many people feeling helpless and wanting to do what they can, but some thieves are preying on that emotion.

Dozens of complaints have been filed from impersonators at people's doors to high pressure callers requesting money for hurricane ravaged areas.



The need is immense, so many are anxious not just to donate money but also collect food, water and medicine along with basics like soap, shampoo, diapers, clothing and shoes.

There are a number of ways to donate from sending supplies for direct relief to sending money through many agencies and charities on the ground in Puerto Rico and across the Caribbean and Texas, which were also hard hit by mother nature this hurricane season and struggling to recover.

To make sure your money gets to the people in need you have to INVESTIGATE before you DONATE.



Legislators and their constituents in the New York Area report an uptick in scammers playing on your heartstrings to get you to open your purse strings .

"My message would be to care with care and make sure you bet who's calling you, who's writing you. The National Hispanic Federation is internationally known organization as well as the NY State Assembly Puerto Rican American task

force are reputable charities on the ground," New York Assemblywoman Rebecca A. Seawright said.

The Assemblywoman spoke at her Upper East Side offices, where a constituent said her phone's ringing relentlessly with scammers asking for her credit card number.

"I would say i get between 6-8 calls a day," said Upper East Sider Helene Goldfarb. "(They're) asking for money and even if I know who the charity is and given to them before. My response is I don't do anything over the phone if you want money send me a note."

That's a smart move everyone should follow these best practices as well.

### Seawright Statement on Rollback of Contraceptive Coverage Mandate

Today, we saw even more evidence that women's rights are under attack in this country. President Trump and his administration are systematically dismantling the progress that has been made in the march toward full women's equality. His latest move – rolling back the requirement that employers provide contraception coverage in their insurance plans – threatens a woman's health, safety and her right to make her own reproductive decisions.



This disgustingly misguided action is yet another attempt to

disempower women and ensure they have less control over their own bodies. By allowing more employers to object to contraception coverage on religious or moral grounds, our president is saying that it's okay for a boss to decide an employee's health and reproductive future. Further, it's completely counterproductive. Access to affordable contraception has been shown to decrease the number of unplanned pregnancies, improve women's health and financial security and lower rates of maternal and infant mortality.

For the single mom already struggling to pay the bills, or the teen girl ready to take charge of her health and body, or the woman who needs birth control to treat her reproductive disorder, losing access to affordable contraception is extremely damaging. Here in New York, we know that women are equal, and we know that they should have control over their bodies, and I will do everything in my power to protect that.

Eastwood and the History of Affordable Housing in New York City

New York Public Library Branch on Roosevelt Island Thursday, October 12, 2017 at 6:30 p.m.

A part of Roosevelt Island's first phase of residential development that opened in 1975, the **Eastwood** building (now known as Roosevelt Landings) is renowned as a milestone in affordable housing.

In this lecture, architect **Matthias Altwicker** who is Associate Professor and Chair at the School of Architecture and Design of the New York Institute of Technology, will discuss the fascinating history of Eastwood and the contributions of its designer, noted architect **Josep Lluís Sert**, then Dean of the Harvard Graduate School of Design. Mr. Altwicker will also discuss the origins and progress of affordable housing in New York City.

The lecture, free and open to the public, is the first in RIHS's annual series of Fall Lectures.

### A Message from The Chapin School

Dear Neighbors,

Please be advised that over the weekend of Saturday, October 14<sup>th</sup> and Sunday, October 15<sup>th</sup> the balance of the tower crane will be delivered and assembled onsite. This work will require a complete street closure from 6:00 AM Saturday through 9:00 PM Sunday on East 84th Street between York and East End Avenues.

Street Closure and Work Hours: October 14th and October 15th

- Street closure signs will be posted at the corners of East 84th Street at York and East End Avenues one week in advance of the closing. Additional NYPD No Parking signs will appear 48 hours prior to the street closure.
- Please note: in advance of this work commencing, all vehicles must be temporarily relocated from the street prior to 6AM Saturday, October 14<sup>th</sup>, or your vehicle will be towed. If your vehicle is towed, tow locations will be available at the 19th Precinct by calling 212-452-0600 (prompt for switchboard operator is 0).
- Residential vehicle ingress or egress will not be permitted at any time until work is completed on Sunday evening. Kindly make arrangements not to schedule any vehicular/truck deliveries during this weekend. Emergency personnel <u>will</u> be able to access the block over the weekend.
- Preparatory work (fence and barricade removal) will begin on Friday October 13, but will not require any lane closings. Two hydraulic assist cranes will remain in place overnight Saturday/Sunday. Security guards will be present 24/7 from Friday morning through Sunday night to patrol the worksite.
- Work hours on Saturday and Sunday will be between 7:00 AM and 9:00 PM.

Please note that information pertaining to crane logistics and operations can be found on Chapin's website - <u>www.chapin.edu/buildingproject</u> - and will be continually updated.

Please also note the crane delivery and installation dates could change due to inclement weather. In the event of a weather delay, we will send another electronic notification on the morning of October 14th noticing our neighbors that the work is postponed. (Our backup rain dates are Saturday, October 21<sup>st</sup> and Sunday, October 22<sup>nd</sup>.)
