# What is a Livable Community?

A livable community is designed to help senior citizens maintain their independence and quality of life. Physical characteristics of a community often play a major role in facilitating our personal independence. Such characteristics include: a safe pedestrian environment, including sidewalks, crosswalks and adequate time to cross the street; easy access to grocery stores and other shops; a mix of housing types; and nearby health centers and recreational facilities - all important elements that can positively affect our daily lives. A livable community has affordable and appropriate housing, supportive community features and services, and adequate mobility options. Together these facilitate personal independence and the engagement of residents in civic and social life. Our goal must be to make all our communities more livable so we can remain living where we want to live.

### **Kent Senior Center**

Putnam County has been working hard to start building a Senior Center in Kent. This facility will address the growing needs of our senior citizen population in the area. I am happy to report that the state legislation, which Senator Leibell and I introduced and which was needed to authorize land use for this project, has been signed by the governor on May 18, 2010. The building of this much-needed community asset can now begin.

### New York State Assembly Legislative Priorities of Interest to Seniors

#### Senior Pedestrian Surveys - A1968

This bill would require the Department of Transportation to conduct a state-wide survey to determine the safety of senior pedestrians and to study the feasibility of suggested methods to enhance the safety of such pedestrians. Every year senior citizens have a disproportionately high representation among those killed or injured in pedestrian incidents. Preventive pedestrian safety measures have been implemented outside New York State, and it is reasonable and prudent that these measures receive scrutiny and consideration for use in New York State.

# Financial Exploitation Prevention Outreach, Education, and Training Program - A4743

This bill would create a Financial Exploitation, Outreach, Education, and Training Program within the New York State Office for the Aging. Seniors are often an attractive target of financial exploitation for a number of reasons. Seniors control over 70 percent of the nation's wealth. They may not realize the value of their assets, and often do not know what action to take when they are the victims of financial abuse. This bill would ensure that seniors receive the education and support they need so they do not become victims of financial abuse.

#### Preserving EPIC Eligibility for Seniors Who Receive Small Increases in Retirement Benefits - A6646

This bill would ensure continuing EPIC eligibility for seniors who receive small increases in Social Security or pension benefits. The already high cost of prescription medicines is continuing to rise dramatically. Cost of living adjustments are usually minimal and quickly spent on other necessary services. It would be unfair to punish seniors who were previously eligible for EPIC but are no longer, solely due to a cost of living adjustment.

# Prohibiting Companies from Charging Customers a Fee for Receiving Paper Bills - A9451

This bill will prohibit businesses from charging customers a fee for choosing to receive a paper bill. In recent months, there have been instances of major companies proposing to impose an additional fee on the accounts of customers that choose to receive a paper bill or pay by United States mail. Such paper billing and payment fees unfairly impact consumers that do not have Internet access in their homes, as well as those who are uncomfortable using the Internet, including many senior citizens and those concerned about personal privacy.

#### Increasing Fines for Deceptive Acts Against the Elderly - A10306

This bill increases penalties for violations of NY's deceptive acts and practices law, including increasing the civil fine for deceptive acts against the elderly from \$10,000 to \$20,000. These improvements would serve to provide a significant deterrent to unscrupulous entities that seek to perpetrate fraud against consumers and ensure that consumers who are victimized are able to obtain justice and be made whole.

### Regarding the Veterans Administration Hospital in Montrose:

I remain committed to and involved in the ongoing discussions regarding the future of the VA Hospital in Montrose. I have attended many meetings to discuss the importance of continuing health services for veterans at the site. I wrote a letter to General Eric Shinseki, the United States Secretary of Veteran's Affairs, inviting him to visit the facility so he can see firsthand how vital the Montrose Hospital is for veterans in our region.
