### **Smart Seniors Launch**

At this year's Senior Forum, New York State Attorney General Eric Schneiderman will announce the launch of "Smart Seniors," a statewide elder fraud prevention program. The goal is to teach seniors how to recognize potential scams before they happen, and to empower seniors by providing them with information they can use to stay safe in their daily lives. We will screen "An Age for Justice: Confronting Elder Abuse in America." This powerful 16-minute documentary film features interviews with four elder abuse victims, and illustrates the devastating impact that abuse can have. The screening will be followed by a short discussion on issues raised in the film.

## Hudson Valley Hospital Center's NICHE Initiative

We will learn more about this new program at the Senior Forum. Hudson Valley Hospital Center (HVHC) in Cortlandt Manor is among only 300 hospitals and nursing facilities in the nation to be accepted by a prestigious network that promotes superior care for older adults. The Hartford Institute for Geriatric Nursing designated HVHC as a NICHE (Nursing Improving Care for Healthsystem Elders) hospital. NICHE is a national geriatric initiative to improve care of older hospitalized adults. To receive the NICHE designation, HVHC had to develop a program that treats older people with compassion, keeps their health from deteriorating and works with their families to prepare patients for leaving the hospital. Nurses have been specially trained to care for geriatric patients in ways which encourage the patients to adopt healthy lifestyles.

### **Assembly Priority 2012 Legislation**

#### A.643-A

#### (Passed Assembly)

This bill would require the Department of Transportation to conduct a state-wide survey to evaluate the safety of senior pedestrians and study the feasibility of enhancing their safety. Every year senior citizens are disproportionately represented among those killed or injured in pedestrian accidents. Preventive pedestrian safety measures have been successfully implemented outside New York State, so it makes sense for New York State to learn from its neighbors.

#### A.9611

#### (Passed Assembly & Senate)

Legislation has recently passed both houses which would allow veterans to have their New York State driver's license indicate that they are a veteran. This bill will be effective in giving standard recognition to veterans on a single identification card. It will also give veterans a convenient form of ID to carry with them in place of other records. This legislation will make it easier for local businesses that provide discounts to veterans to identify such customers.

#### A.2154-A

#### (Passed Assembly)

This bill would require the New York State Office for the Aging to publish a guide explaining the purpose, function, potential side-effects, and potential drug interactions of drugs commonly used by persons over the age of 62. Since seniors are often prescribed multiple medications and/or take over-the-counter medicines whose interactions can be life threatening, such a guide would be useful in making seniors aware of the likely contraindications of certain commonly prescribed drugs and over-the-counter medications.

#### A.9352

#### (Currently in Assembly Codes Committee)

I am a co-sponsor of this bill, which would prohibit business entities from charging extra fees when customers pay with a method deemed "undesirable." Currently, companies may charge additional fees specifically for customers who choose to mail in payments. This legislation would still allow companies to encourage specific forms of payment, but would prevent them from penalizing those customers unable or unwilling to pay in that form.

## **New York State EPIC Funding Restoration**

We have restored \$30.6 million to the Elderly Pharmaceutical Insurance Coverage (EPIC) program. This program covers drugs on a senior's Part D formulary during the initial coverage and catastrophic phases of Medicare Part D. The initial coverage phase is when Part D co-payments average 25% of the drug's cost. Under this change, which takes effect on January 1, 2013, seniors will only be responsible for their EPIC co-payment, which will be no higher than \$20. This is an improvement from the 25% part D co-payment. Those who wish to benefit from the restored EPIC program must first enroll in a Part D Plan.
