### Legislation to Support Veterans

In the fight against veteran homelessness, the Assembly passed laws to help veterans find well-paid work, including tax credits for small businesses that hire veterans (Ch. 59 of 2013) and the Veterans Employment Act to help give veterans temporary staffing jobs in state agencies (Ch. 557 of 2013). This year, the Assembly passed legislation that would direct key state agencies to gather information on the state's homeless veterans and their children ([A.434](#)). In addition, New Yorkers can easily contribute to The Homeless Veterans Assistance Fund, by simply checking a box on their income tax forms ([Ch. 428 of 2014](#)).

### Opposing Increased Bridge Tolls

During a budget meeting in Albany, NYS Thruway Authority officials announced that tolls on the Tappan Zee Bridge would [not increase in 2016](#) and that a special seven-member advisory panel would recommend, by the middle of next year, whether to raise tolls for the New NY Bridge. I have adamantly opposed doubling or tripling bridge tolls. I will continue working with my colleagues to ensure toll increases are minimal and affordable. Read more [here](#).
