

- Inficon in East Syracuse - \$3.5 million
- G.A. Braun in North Syracuse - \$1.5 million
- Stickley in Manlius - \$975,000
- Byrne Dairy's Ultra Dairy in Onondaga - \$750,000

Cut taxes on business to spur job growth

- Eliminated the income tax and cut property taxes on manufacturers
- Slashed the corporate tax rate to attract new businesses
- Cut an energy tax, saving customers \$600 million

Investing in Central New York's economic future

- Helped create a tax-free zone at Onondaga Community College, to bring new business and jobs to Central New York
- Secured \$600,000 for advanced manufacturing training to help workers get the necessary skill set to secure good-paying jobs
- Helped secure nearly \$67 million for local projects through the Central New York Regional Economic Development Council (CNYREDC)

Helping hardworking families

- Increased the minimum wage to help invest in our workforce
- Secured a \$350 rebate check for families with children
- Provided property tax rebate checks for homeowners
- Lowered the income tax rate for middle-class families
