## New Legislation:

### *Solar Energy*

Last week I introduced, [A10410](#), which would provide a tax abatement for electric energy storage equipment in New York City. This bill would help defray upfront costs and help catalyze energy storage in New York City while driving down unit and installation costs. This bill goes along with [A10150](#), a bill that I am sponsoring that would extend the already existing tax abatement for solar electric generating systems in NYC. These bills together encourage more investment in solar energy and are critical to help meet and exceed our goal of using 50% renewable energy by 2030.

### *Public Corruption*

This week, along with Senator Liz Krueger, I introduced [A10651](#), which is a proposed Constitutional Amendment to replace the Joint Commission on Public Ethics (JCOPE) and the Legislative Ethics Commission (LEC) with a single, truly independent, enforcement agency that would deter corruption in the legislative and executive branches of state government. It is widely recognized that New York has a corruption problem. Polling shows that over 80 percent of registered voters think corruption in Albany is a "serious problem." Numerous former high-ranking New York State government officials are on trial this spring. One has just been convicted. In the past 15 years, according to the Syracuse Post-Standard, at least 21 state legislators, former legislators and other elected state officials have been sentenced to prison or house arrest. There are a host of flaws in the current JCOPE/LEC structure and this proposed constitutional amendment is designed to cure those flaws by providing credible independence, ample powers and secure funding. The result would produce a New York State Government Integrity Commission which can't be ignored or dismissed as a paper tiger. [I encourage you to read more about the bill here.](#)

### *Fees for Uber/Lyft and other app-based networks*

Also this week I introduced [A10669](#), which would establish a \$10 licensing fee on transportation network company drivers for each transportation network account (Uber, Lyft, Via, Juno etc.) a driver accesses and deposit those licensing fees into the MTA finance fund. You may have read the [NY Times Oped Entitled "What Will New York Do About Its Uber Problem?"](#) on May 7<sup>th</sup>. In the piece The Times correctly notes that Governor Cuomo and the Legislature missed a critical opportunity during the budget process to establish a comprehensive congestion pricing plan in the style of the Fix NYC Advisory panel's recommendations. It was truly unfortunate that the Governor did not submit his own commission's recommendations to the Legislature during the budget process. In the State Assembly, I was one of the most outspoken proponents of the FixNYC plan because of the much needed revenue it would raise for the MTA (\$1.5 billion annually), the reduction of congestion in Manhattan's Central Business District, and the positive effects it would have on our air quality and our environment.

Fortunately, with [A.10669](#), we can still raise meaningful revenue for the MTA, reduce congestion, and improve our air quality and environment this legislative session. The opportunity to use our roads and pick up passengers is a great benefit and app-based drivers should pay their fair share. The license would last 24 hours from when the driver accesses any one of the many ride hailing apps. This per day licensing fee, paid by the ride-hailing app driver, at the beginning of his/her day, will have a deterring effect on the casual ride-share driver who only plans to work a few hours and who in the meantime provides little positive benefit because that driver clogs our streets, pollutes our air and statistically roams our streets twice as long as a traditional yellow cab before picking up a passenger. Winnowing down this population of amateur drivers in NYC is necessary to controlling the massive expansion of app-based ride hailing platforms. Conversely, the Uber or Lyft driver who works 5 or 6 days a week for 8 to 12 hours will be more than able to cover this nominal fee. Finally, this per day, per app driver fee will conservatively raise

\$100 to \$150 million dollars a year and cost drivers a yearly total of between \$1,000 and \$4,000 dollars depending on how many days they drive and how many apps they use per day.


