## ***The Holiday Season: A Time to Give Thanks and Help Those In Need***



The holidays are a happy time of year for many, when we can gather with friends and family and end the year with laughter, friendship and good cheer. It's an opportunity to reflect, set new goals and appreciate all that we have. But as we prepare to dig into our Thanksgiving turkey and other holiday feasts, it's important to remember that there are many in our community who are less fortunate and have trouble just getting by.

Hunger is a widespread problem here in New York, where 1 in 5 children struggle with food insecurity, according to the hunger-relief organization Feeding America. These children and their families are at risk of an even more perilous situation as the federal administration is considering cutting funding for vital programs that help low-income residents put food on the table. For instance, earlier this year, President Trump released a proposed budget that slashes federal funding for the Supplemental Nutrition Assistance Program (SNAP), more commonly known as food stamps, by nearly \$200 billion over the next 10 years. This could aggravate an already desperate situation for millions of families and

overwhelm food banks as more and more are forced to rely on them.

It's up to us. Not only must we continue to pressure the federal administration to protect our most vulnerable residents who face food insecurity, but we also must take immediate action in our own community. That's why the Assembly Majority has continuously been at the forefront of fighting poverty, combating inequality and creating more opportunity. Earlier this year, the Assembly fought to create a 25 percent tax credit on qualified food donations that farms make to food banks, up to \$5,000 per year. We also made it easier for school districts and institutions of higher education to donate excess food to local community organizations, food pantries and soup kitchens (Ch. 316 of 2017).

We can help here at home, too. Since many food banks rely on charitable donations, we can extend the spirit of giving and help others enjoy the holiday season by volunteering our time or donating products to a local food pantry. Our community is strong because we step up and look out for one another.

## ***HEAP is here to help make heating bills more affordable***

Autumn may have blessed us with extra sunshine and warmer-than-average temperatures this year, but that doesn't mean that winter is going to be as kind to us. As New Yorkers, we're all too familiar with the harsh weather the season can bring, as well as the high heating bills that come with it. Fortunately, the Home Energy Assistance Program (HEAP) can help cover those costs.



Call 1-800-342-3009 to find out how you can get help with high heating bills.

HEAP, a federally funded program, provides financial assistance to both renters and homeowners and can be used to help cover the costs of electricity, propane, natural gas, wood, oil, kerosene, coal or other heating fuels. Eligible families can also apply for funds to help pay for home heating equipment and repairs.

Eligibility for HEAP relies on a number of factors, including income, household size, primary heating source and whether a member of the household is under the age of 6, over the age of 60 or permanently disabled. For the upcoming winter, a family of four that has a household income of up to \$4,457 a month may qualify for help. Applications are now being accepted, and please note that assistance is granted on a first-come, first-served basis. This year, households can receive up to \$726 in assistance. An extra emergency payment is also available to households that are out of fuel or going to have their service shut off. Applications for an emergency benefit open on Jan. 2, 2018.

Time and again, HEAP has proven to be a critical lifeline to millions of Americans, with about 1.4 million New Yorkers receiving assistance last year. But, in yet another display of his lack of compassion, President Trump has proposed cutting the program. The Trump administration has claimed the program is "no longer a necessity," but that couldn't be further from the truth for the low-income families and the elderly who desperately rely on it to keep their homes warm as energy prices continue to rise. Although cruel proposals like this have become all too common with the Trump White House, I'll keep doing everything I can to protect New York families and ensure they have the assistance they need.

### ***Seawright's Black Friday Consumer Alert***

Assembly Member Seawright, Chair of the Subcommittee on Consumer Fraud Protection issued a warning to her constituents before Thanksgiving and the day after, known as Black Friday. Seawright signed on to cosponsor a bill in the Assembly, which would comprehensively update the deceptive acts and practices statute in Section 349 of the General Business Law to increase the penalties for unfair or deceptive acts and practices and lay out factors for courts to consider in determining whether an act or practice is unfair. This bill also allows consumers to bring civil actions to recover damages from scams.



"As Chair of the Subcommittee on Consumer Fraud Protection, I want to alert my constituents to the fraud that can arise during the holiday season. All too often, consumers are scammed during what is supposed to be the most joyous and generous time of year. Be wary of deals that seem too good to be true and contact our office if you suspect any deceptive practices," said Seawright.

**No Garbage, Organics, Recycling Collection, or  
Street Cleaning on Thanksgiving Day,

The New York City Department of Sanitation announced that in observance of Thanksgiving Day, there would be no garbage, organics nor recycling collection, or street cleaning, on Thursday, November 23, 2017.

- Residents who normally receive Thursday **garbage and organics collection** should place their materials out at curbside after 4 p.m. on Thursday, November 23 for pickup.
- Residents who normally receive Thursday **recycling collection** should place their materials out at curbside after 4 p.m. on Wednesday, November 29 for collection on Thursday, November 30.

In addition, all Sanitation administrative offices will be closed on Thursday, November 23, in observance of the holiday.

**NOTE: There is normal collection service on Friday, November 24, 2017.**

To help provide city residents with Sanitation-related service reminders, updates and special event schedules, the New York City Department of Sanitation has launched DSNY Info, its smart phone and tablet app. The app also includes tips to reduce, reuse and recycle, making it easier for New Yorkers send zero waste to landfills by 2030.
