Dear Governor Cuomo, Legislative Leaders & Commissioner Ball:

As New York's elected leaders, our responsibilities to constituents have never been more important. Your efforts to provide leadership and stability during the unprecedented COVID-19 crisis are genuinely appreciated.

With more than 180,000 cases of the virus, no state has felt the social, economic, and public health effects of the virus like New York. As we identify ways to manage and minimize the devastating impacts of the virus, we must consider immediate steps to provide critical relief to New York State's agricultural industry.

New York State is home to 33,400 farms, including 4,000 dairy farms – they are a pillar of our economy, just as they have been for generations. But more importantly, our farms are the driving force of our food supply. As one of America’s top dairy-producing states, New York’s entire agricultural industry is trying to navigate through unimaginable hardships that necessitate a historic commitment from State leaders.

Measures to prevent the spread of the virus have led to severe disruptions to the dairy industry’s supply chain, dramatic reductions in demand, and have forced many farmers to dump valuable product. The Assembly Minority Conference has compiled a list of recommendations to help our farms survive and stabilize State and local economies. Farmers need immediate help. I hope that we can work collaboratively, along with the appropriate State agencies, to implement these changes and get New York’s agricultural community back on track. Our recommendations include:


- Suspend, for 1 year, DMV registration requirements for agricultural vehicles and farm trucks;
- Suspend the highway use tax, special hauling permit fees, and collection of New York State tolls for vehicles used to transport agricultural products, including milk;
- Suspend, for 1 year, the 60-hour overtime threshold for farm laborers enacted as part of the 2019 Farm Labor bill;
- Suspend, during the state of emergency period, the 24-hour agricultural rest requirement;
- Extend the Milk Producers Security Fund to help producers who are unable to sell because of COVID-19;
- Use additional federal stimulus money for direct cash infusions for Cornell Cooperative Extensions to assist in the provision of emergency services;
- Use federal stimulus funding to invest in rural broadband infrastructure to assist in the provision of services to farms/rural areas during uncertain social and economic times;
- Provide vouchers for food banks to purchase local dairy and agricultural products; and
- Stipulate “green nurseries” as essential businesses for the remainder of the COVID-19 crisis, so that these businesses can re-open while following social-distancing guidelines.

Since the birth of our nation, farming has been part of the very fabric of our history. Farming represents much more than just an industry or occupation – it is a calling that requires unique character, an unrivaled work ethic, and an unwavering commitment to provide food and products upon which the entire world relies. The survival of our agriculture industry is essential to our collective recovery and our future well-being long after we have defeated the COVID-19 pandemic.

As you know, time is of the essence. Every day that passes without meaningful action is another day of uncertainty for farming families, or another day farms move closer to closing their doors. We hope the State can act with speed, urgency, and collaboration to provide substantial relief to New York’s farmers.
