New York to Allow Small Religious Gatherings

Amid Coronavirus Pandemic

Antibody Testing Reveals Higher Rate of COVID-19 Infection in Low Income and Minority Communities; All 50 States Have Relaxed Restrictions; CDC Releases New Guidance; and More!

NYS: GOVERNOR CUOMO

- New York will allow religious gatherings of **up to 10 people** starting Thursday.

- Attendees must wear **masks** and maintain **social distance**.
- **Drive-in and parking lot services** will also be allowed.
- Governor Cuomo said the state's antibody testing survey at churches in lower-income NYC communities of color show **27%** of individuals **tested positive** for COVID-19 antibodies.
 - Here are the results of the church survey by borough:
 - Bronx: **34%**
 - Brooklyn: **29%**
 - Manhattan: **20%**
 - Queens: **25%**
 - Staten Island: **19%**
 - The state will expand the program from **8** to **40** public housing sites across NYC.
 - Cuomo said New York will partner with **SOMOS** to establish **28 more sites**.
 - They will be in predominately minority neighborhoods.
- The state got **600 submissions** to the **#WearAMaskNY** contest
 - There are **5** finalists.

NYC: MAYOR DE BLASIO

- Mayor de Blasio urges parents to get children vaccinated.
 - Health department data shows the number of kids getting vaccinated is **down 63%** overall.
 - For children **over age 2**, it is down a staggering **91%**.
- Data from **NYC 311** shows that most complaints related to violations of the city's face-covering rules are coming from affluent areas of Manhattan and Brooklyn.
 - About **4,000 people** have reported violations since the system began tracking about **3 weeks ago**.
- The city will be expanding testing for **residents** at all **169** nursing homes.

- **On-site PCR tests** will be available to all nursing homes starting next week.
- Employees who test positive will have to stay home for **14 days**.
- To help with staff shortages, the city is deploying **240** personnel. The **surge staff** will fulfill staffing requests by the end of the week.
- The city says there is sufficient **PPE** to last us through the month.
 - Once there is a **14-day supply**, the city will begin building a **90-day** reserve supply, which de Blasio hopes to have stockpiled by the end of the year.

FEDERAL GOVERNMENT

- **Speaker Pelosi** initiated a **45-day** remote work period so the House can use proxy voting.
 - Meanwhile, **Senator Mitch McConnell**, the majority leader, noted the Senate's ongoing presence in Washington.
- All **50 states** have now eased restrictions and are **beginning to reopen**.

World Health Organization

- **Tedros Adhanom-Ghebreyesus**, the director-general of the **World Health Organization (WHO)**, said more cases have been reported to the agency in the last **24 hours** than any time since the outbreak began.
 - **106,000** cases were reported.
 - **Two-thirds** of the reports came from just **4** countries.
 - Those countries are the **United States, Russia, Brazil and India.**

- The **CDC** released a **60-page** [document](#) with new COVID-19 guidelines. Some highlights are:
 - When a student tests positive, **schools** should evaluate the risk and consider a brief dismissal of about **2 to 5 days**, to clean and disinfect the building, coordinate with local health officials and contact trace.
 - **Bar and restaurant owners** should offer workers at a **higher risk** of getting sick **a job that limits the person's interaction with customers**.
 - **Mass transit** will need to **adjust routes** based on levels of COVID-19 transmission.
 - The coronavirus **does not** spread easily on surfaces and objects.

- The virus continues to spread primarily from **person to person**.

MULTISYSTEM INFLAMMATORY SYNDROME IN CHILDREN (MIS-C)

Governor Cuomo announced that a new investigation is underway regarding potential COVID-19 related **cases in children**. Symptoms can be compared to Kawasaki disease and toxic shock-like syndrome. The Department of Health issued an advisory of what's called the Multisystem Inflammatory Syndrome in Children, or MIS-C, and now **requires** health care providers to **immediately report** all related cases. The Department of Health and Mental Hygiene released a [health advisory](#) detailing current findings.

- New Yorkers should **seek immediate** care if a child has:
 - Prolonged fever (more than five days)
 - Difficulty feeding (infants) or is too sick to drink fluids
 - Severe abdominal pain, diarrhea or vomiting
 - Change in skin color - becoming pale, patchy and/or blue

- Trouble breathing or is breathing very quickly
- Racing heart or chest pain
- Decreased amount of frequency in urine
- Lethargy, irritability or confusion

WHAT TO DO IF YOU ARE SICK WITH COVID-19



What to do if you are sick with coronavirus disease 2019 (COVID-19)

If you are sick with COVID-19 or suspect you are infected with the virus that causes COVID-19, follow the steps below to help prevent the disease from spreading to people in your home and community.

Stay home except to get medical care

You should restrict activities outside your home, except for getting medical care. Do not go to work, school, or public areas. Do not use public transportation, ride-sharing, or taxis.

Separate yourself from other people in your home

As much as possible, you should stay in a specific room and away from other people in your home. Also, you should use a separate bathroom, if available.

Call ahead before visiting your doctor

If you have a medical appointment, call the healthcare provider and tell them that you have or may have COVID-19. This will help the healthcare provider's office take steps to keep other people from getting infected or exposed.

Wear a facemask

You should wear a facemask when you are around other people (e.g., sharing a room or vehicle) and before you enter a healthcare provider's office. If you are not able to wear a facemask (for example, because it causes trouble breathing), then people who live with you should not stay in the same room with you, or they should wear a facemask if they enter your room.

Cover your coughs and sneezes

Cover your mouth and nose with a tissue when you cough or sneeze. Throw used tissues in a lined trash can and wash your hands with soap and water for at least 20 seconds. If soap and water are not available, immediately clean your hands with an alcohol-based hand sanitizer that contains at least 60% alcohol, covering all surfaces of your hands and rubbing them together until they feel dry. Soap and water should be used preferentially if hands are visibly dirty.

Clean your hands

Wash your hands often with soap and water for at least 20 seconds. If soap and water are not available, clean your hands with an alcohol-based hand sanitizer that contains at least 60% alcohol, covering all surfaces of your hands and rubbing them together until they feel dry. Soap and water should be used preferentially if hands are visibly dirty. Avoid touching your eyes, nose, and mouth with unwashed hands.

Avoid sharing personal household items

You should not share dishes, drinking glasses, cups, eating utensils, towels, or bedding with other people in your home. After using these items, you should wash them thoroughly with soap and water.

Monitor your symptoms

Seek prompt medical attention if your illness is worsening (e.g., shortness of breath or difficulty breathing). **Before** seeking care, call your healthcare provider and tell them that you have, or are being evaluated for, COVID-19. Put on a facemask before you enter the facility. These steps will help the healthcare provider's office keep other people from getting infected or exposed.

Ask your healthcare provider to call the local or state health department. Persons who are placed under active monitoring or facilitated self-monitoring should follow instructions provided by their local health department or occupational health professionals, as appropriate. <https://www.cdc.gov/coronavirus/2019-ncov/php/risk-assessment.html>.

Discontinuing home isolation

Patients confirmed to have COVID-19 should remain under home isolation precautions until the risk of secondary transmission to others is thought to be low. The decision to discontinue home isolation precautions should be made on a case-by-case basis, in consultation with healthcare providers and state and local health departments. Current information on COVID-19 is limited; home precautions are conservative and based on general recommendations for other diseases, like Middle Eastern Respiratory Syndrome (MERS).
