NYS Benefits for Our Veterans with Disabilities



New York State Motor Vehicle Registration Fee Exemption

Through the New York State Department of Motor Vehicles (DMV), Veterans with disabilities can qualify to be exempt from registration fees and vehicle plate fees.

NYS Blind Annuity Program

The Blind Annuity Program benefit is for legally blind wartime Veterans, or surviving un-remarried spouses of legally blind wartime Veterans, who live and are domiciled in New York State. Blindness need not be a service-connected disability.

If a Veteran met all the criteria for the Blind Annuity benefit, but never actually received the benefit during their lifetime, the un-remarried surviving spouse of that Veteran may still be eligible to receive the benefit.

E-ZPass for Disabled Veterans

The New York State Thruway Authority offers free, unlimited travel anywhere on the Thruway to certain qualifying disabled Veterans. The Thruway Authority's only qualifying criteria for the Disabled Veterans E-ZPass Non-Revenue program is a fee-exempt vehicle registration from the Department of Motor Vehicles (DMV).

Veterans' Affairs Committee Updates

Bills Signed into Law as of 1-14-26

A6579, STERN

Tax relief for the men and women who serve our nation - this legislation provides a property tax exemption for active service members whose military duty station is within the boundaries of New York State and has served in a combat zone anytime during the taxable year.

SIGNED INTO LAW 12/19/2025

A8485, STERN

Requires the Department of Veterans' Services to provide information on the department's website on volunteer opportunities available to veterans and to post relevant application forms that a qualified veteran can use to apply for volunteer opportunities.

SIGNED INTO LAW 12/19/2025

A6264, STERN

Expands the definition of a veteran to include members of the commissioned corps of the National Oceanic and Atmospheric Administration and the commissioned corps of the Public Health Service

SIGNED INTO LAW 12/5/2025

A8476, STERN

This bill enacts the Governing Unaccredited Representatives Defrauding (GUARD) VA benefits act to increase penalties on individuals and entities who act in violation of federal and state law related to preparing, presenting or prosecuting claims for veterans benefits including soliciting or receiving compensation in connection with a claim for VA benefits without being properly accredited by the United States Department of Veterans Affairs.

SIGNED INTO LAW 11/5/25



A291, BARRETT

Extends State benefits to service members and veterans of the Space Force

SIGNED INTO LAW 12/5/2025

A8475, BERGER

Makes technical corrections to the title of the Commissioner of Veteran's Services

SIGNED INTO LAW 11/21/25

A4751A, RAJKUMAR

Ensures that New York State and local veterans' service agencies include disabled veterans in employment assistance obligations.

SIGNED INTO LAW 11/5/25

A29, McDONALD

Designates New York State a Purple Heart state, honoring our combat veterans for their service and sacrifice.

SIGNED INTO LAW 11/5/25

A2058, CUNNINGHAM

Requires the Women Veterans Coordinator of the Department of Veterans' Services to develop and implement a maternity care program for pregnant and postpartum veterans.

SIGNED INTO LAW 2/14/2025

A2435, CRUZ

Regarding the definition of "intended recipients" of the Alex R. Jimenez New York Military Immigrant Family Program to specifically include spouses, parents, and children of a uniformed service member, veteran, or reserve component member as well as the next-of-kin of such service members and veterans requesting a grant of posthumous U.S. citizenship on their behalf.
