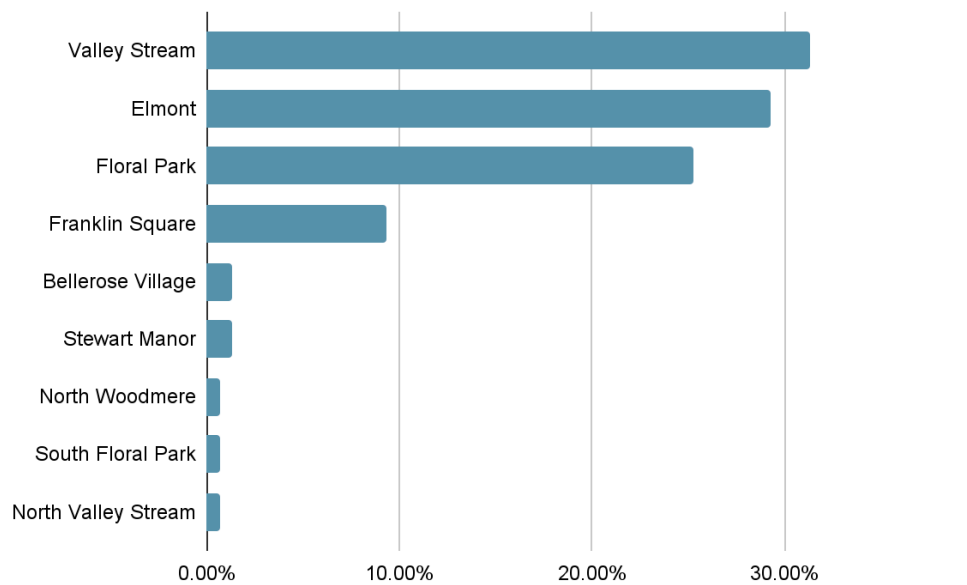

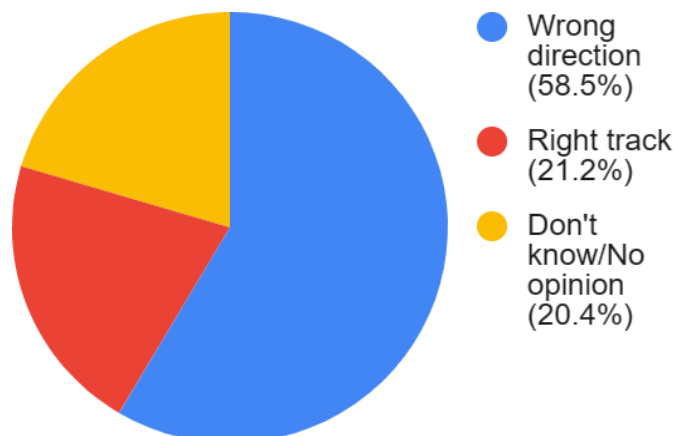

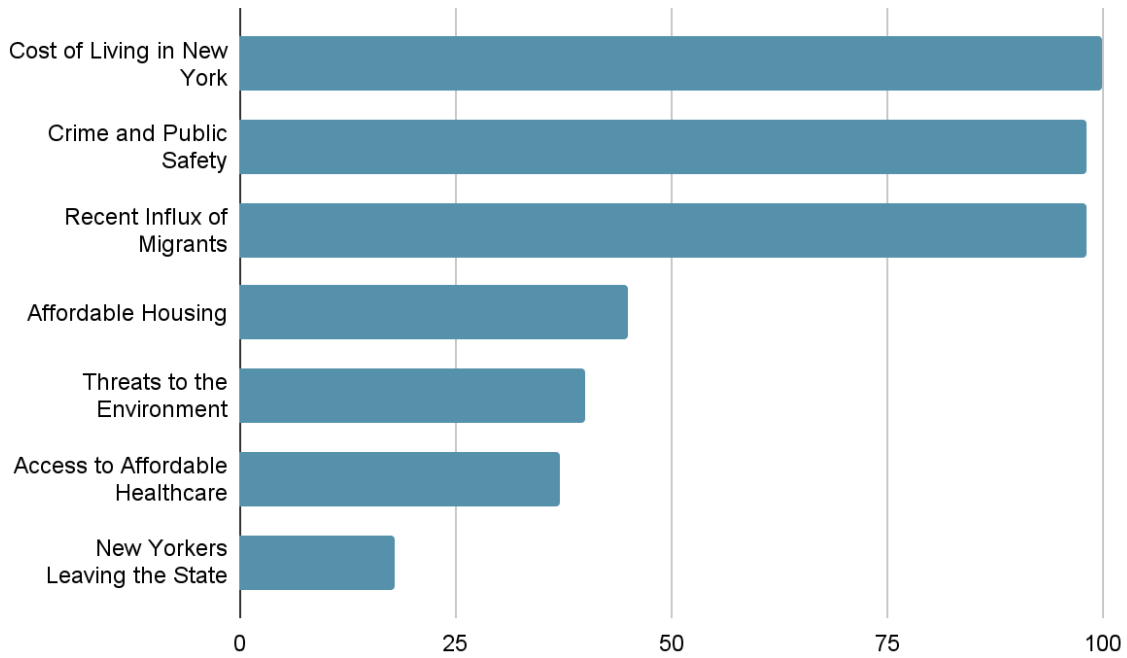
### 1. Constituent's Town of Residence:



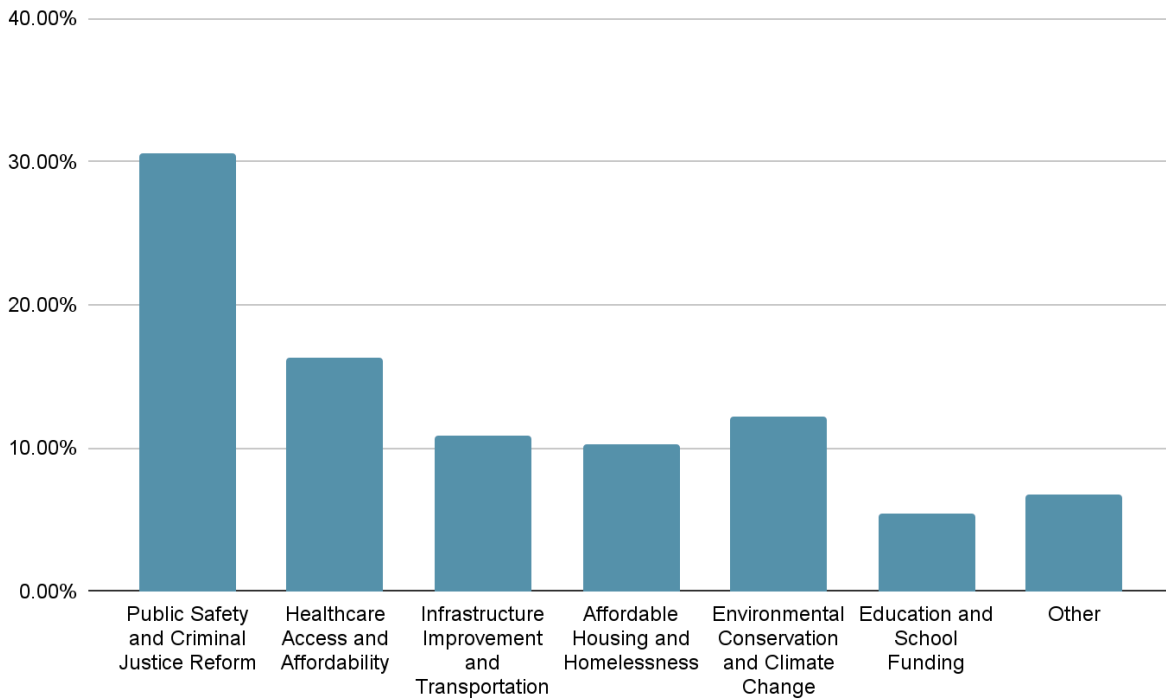
### 2. Is New York State on the right track, or is it headed in the wrong direction?



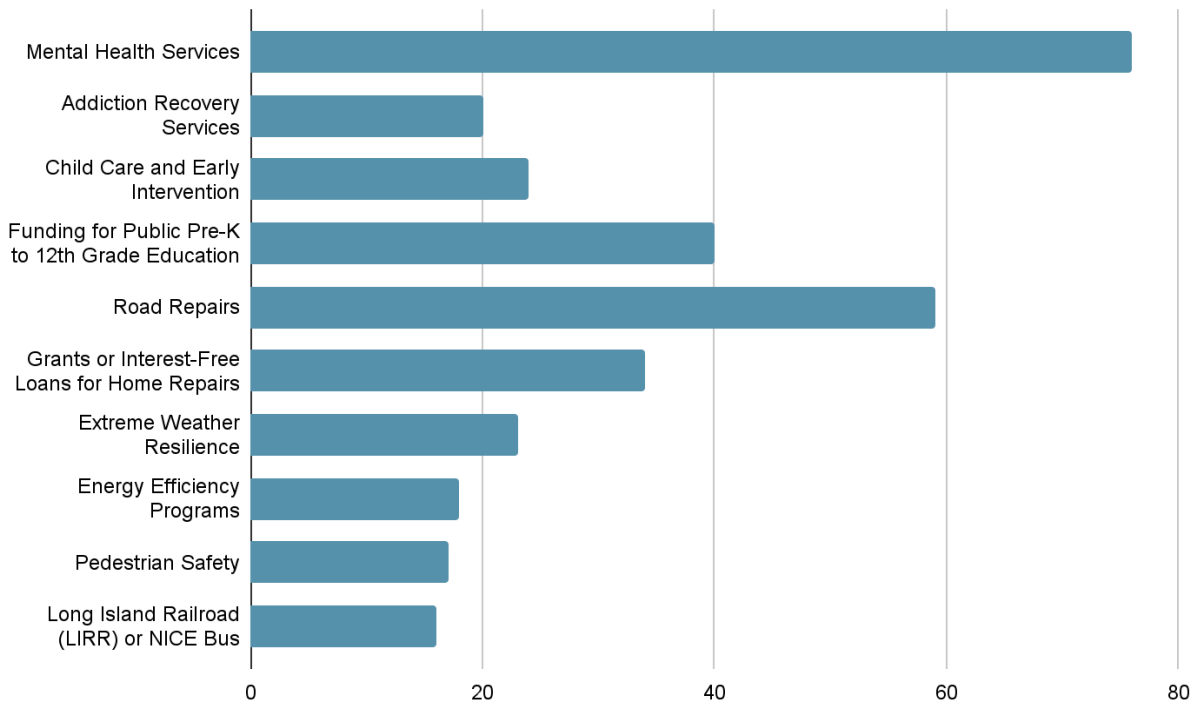
3. What do you think are issues that the governor and legislature should be working on now (select top three)?



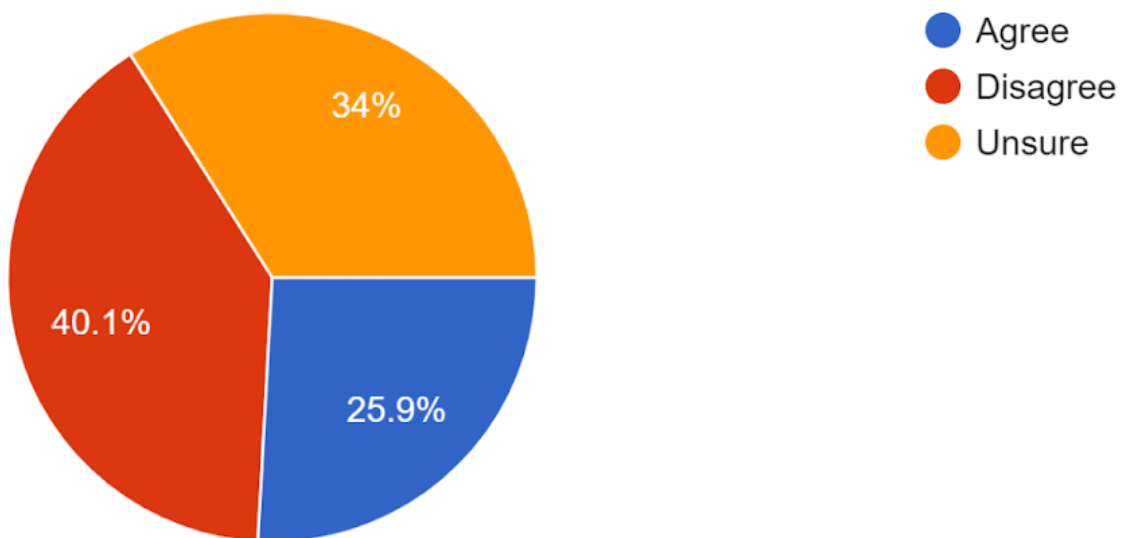
4. Please select one policy area that is of particular importance to you:



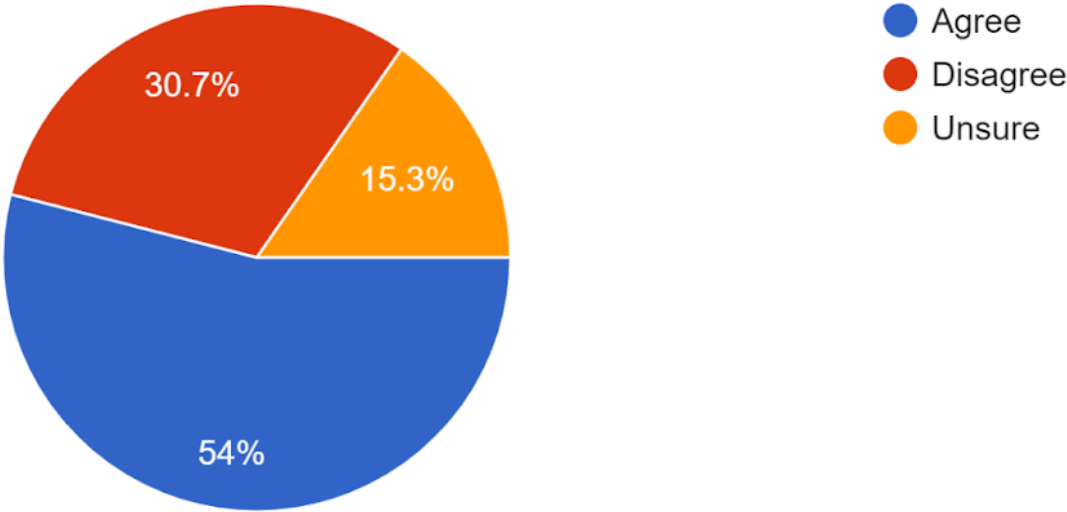
5. Of the following issues, where should the New York State Budget allocate more funds (select top three)?



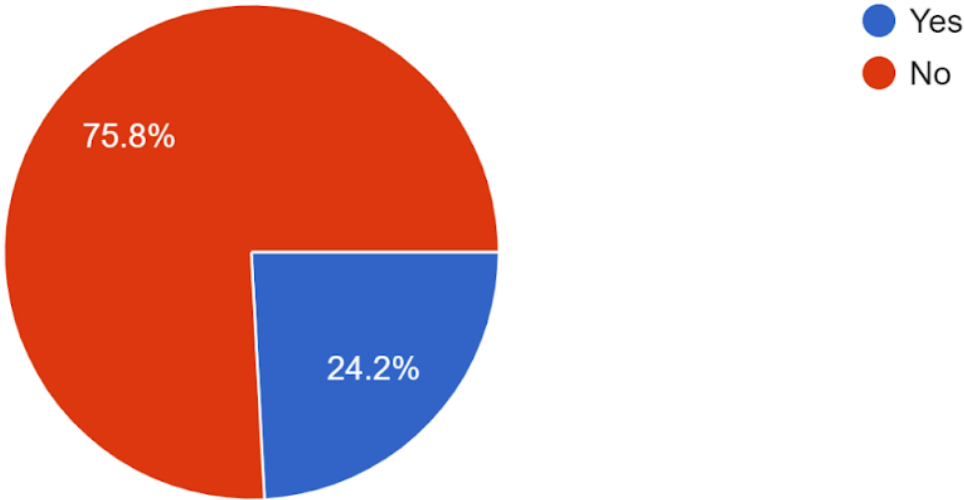
6. Do you favor industrial development agencies (IDAs) granting tax incentives to developers for housing construction?



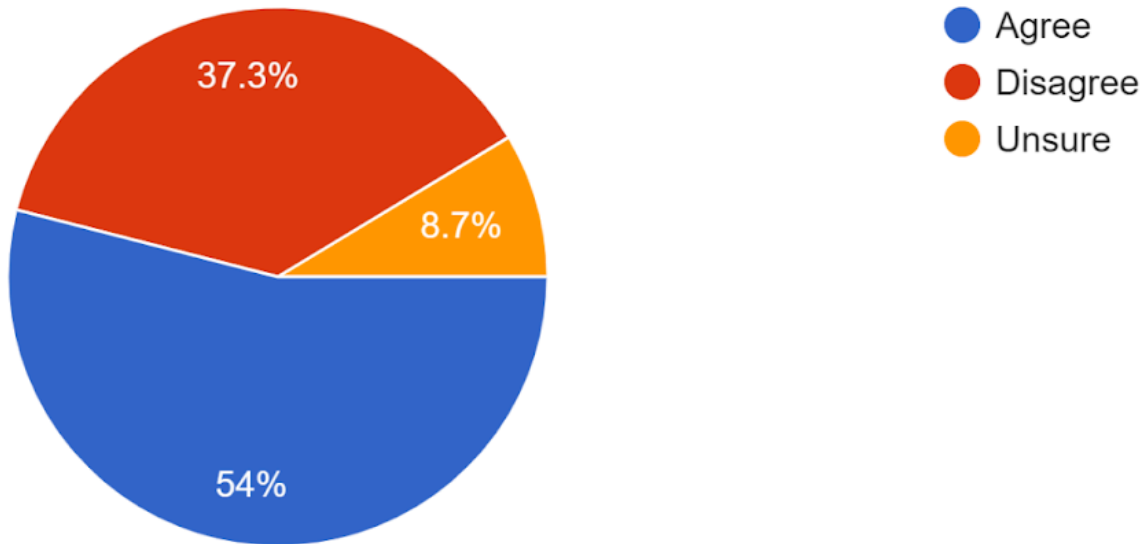

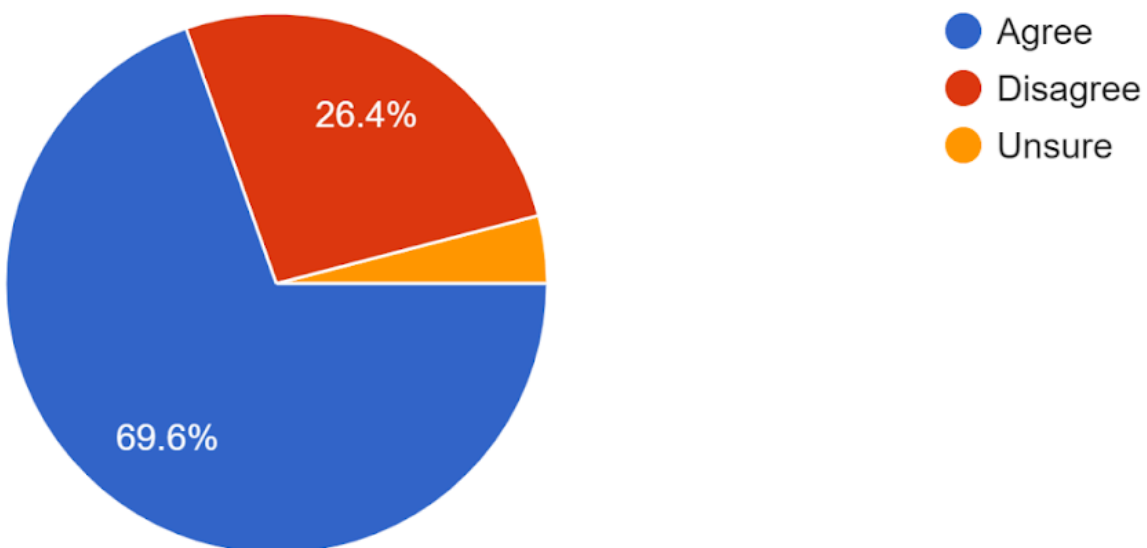
8. Were you affected by the rain and flooding that occurred from September 28th to September 30th, 2023?



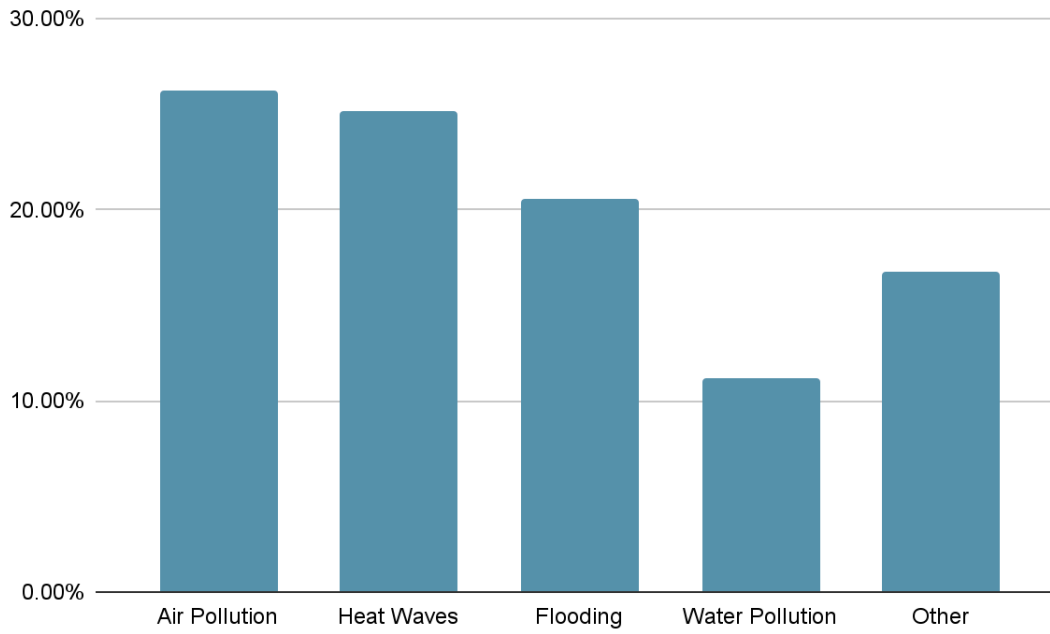
9. Have you experienced financial strain due to rising utility bill costs?



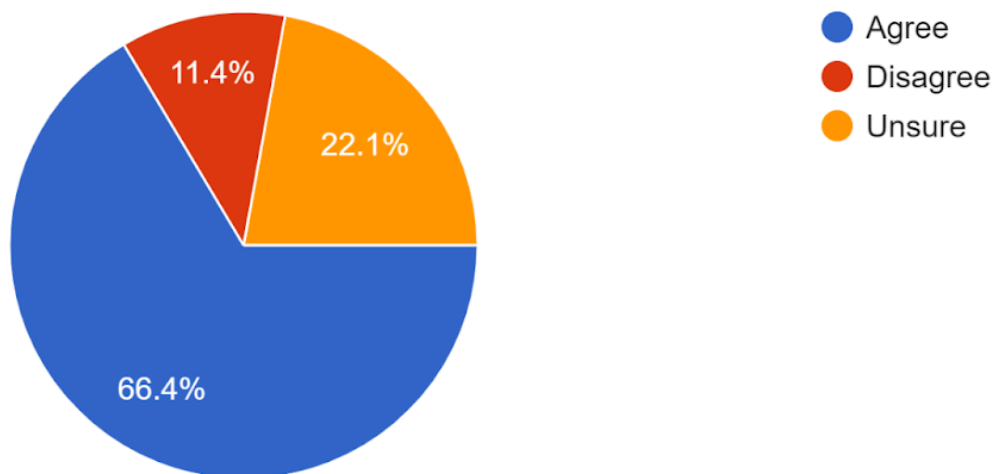
10. Are you concerned about the impact of climate change/global warming on the quality of life?



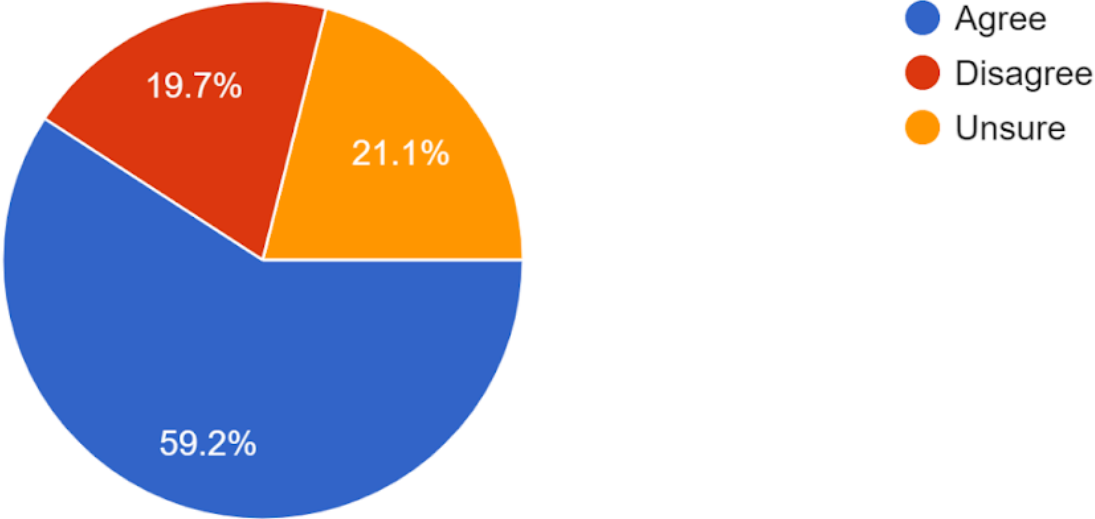

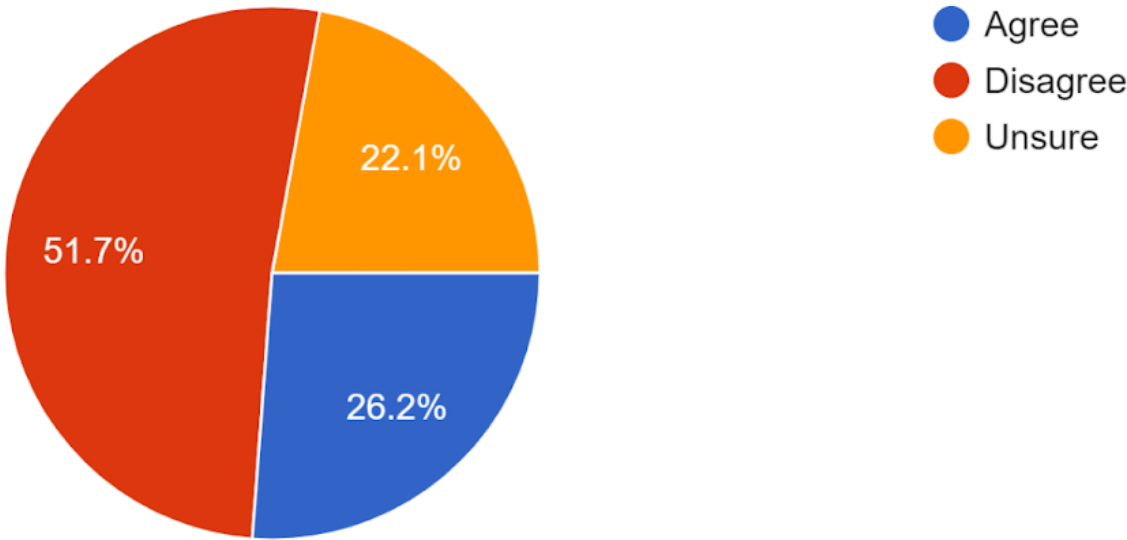
12. Do you believe that for-profit utility companies should be banned from lobbying in New York State?



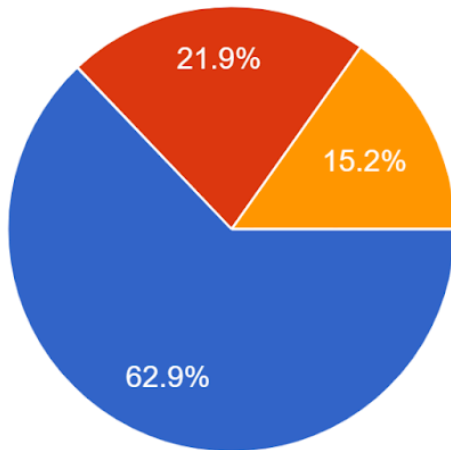
13. Would you support legislation that would cap utility bills for low- and middle-income New Yorkers at 6% of their income?



14. Do you support the elimination of the 100-foot rule subsidies and requiring homeowners to pay for their own gas hook-up?

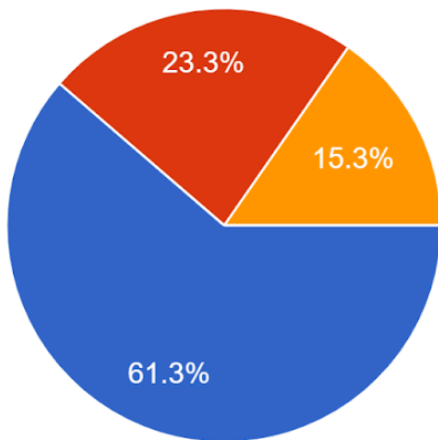

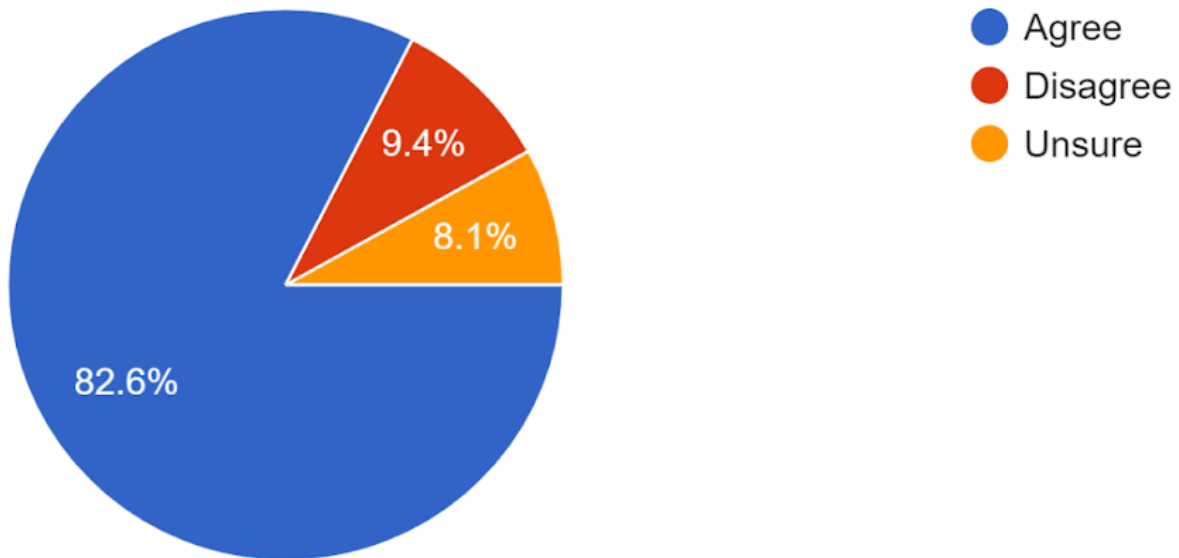
16. Do you support the construction of wind turbines and transmission lines on Long Island to enhance renewable energy generation and distribution?



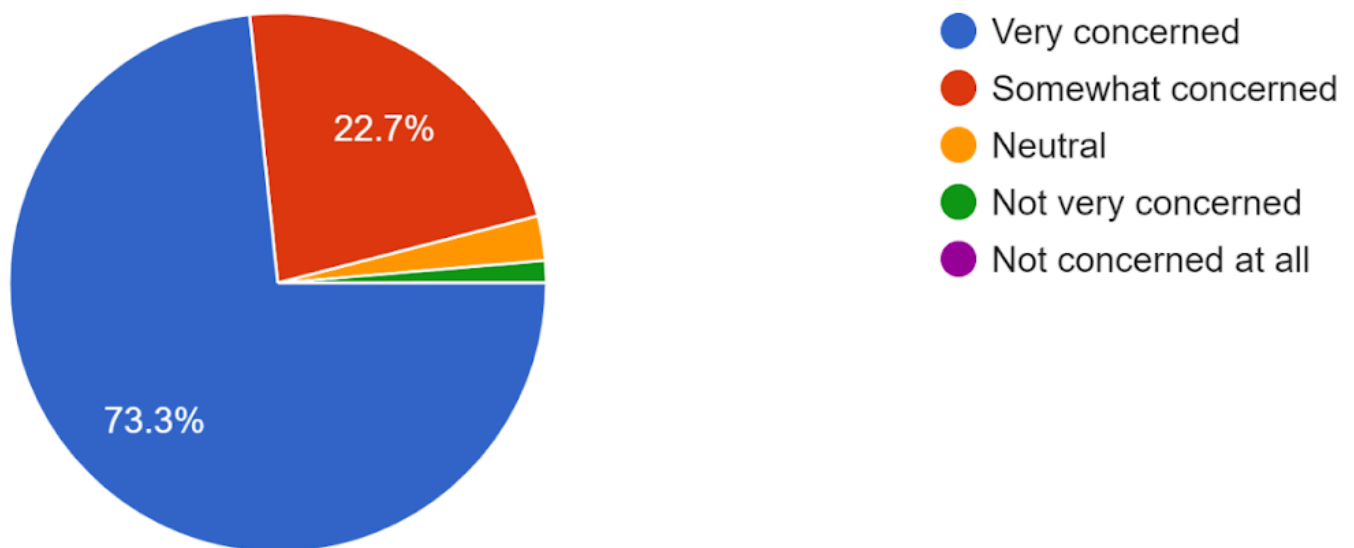

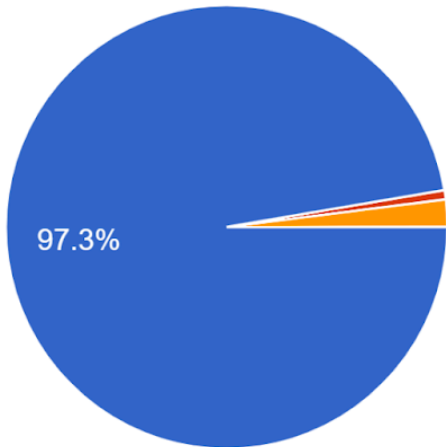
17. Do you believe New York State should pass legislation limiting teenage access to algorithmic social media?



18. With the increasing use of technology and data collection, how concerned are you about your personal Privacy in the Digital Age?

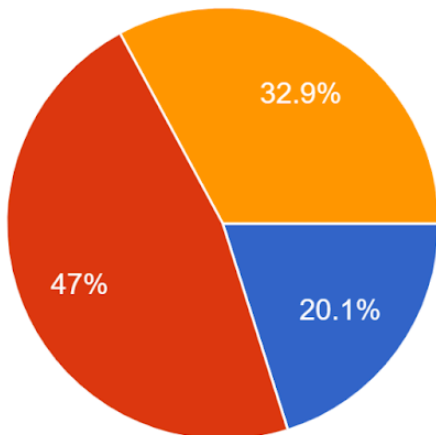


19. Do you believe that individuals should have the right to opt out of data collection and have greater control over their online privacy?



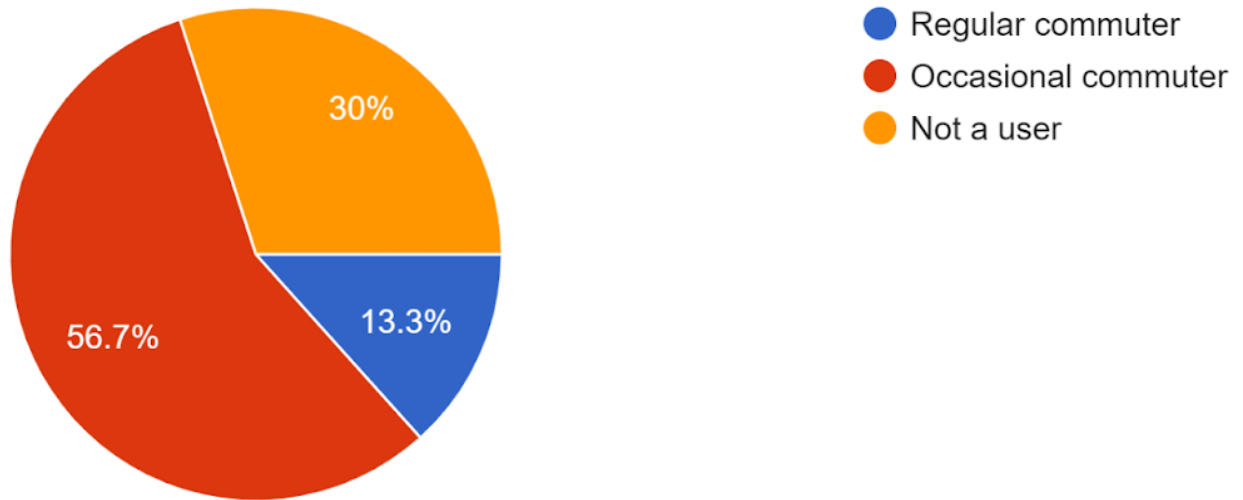

- I'm undecided or need more information to form an opinion

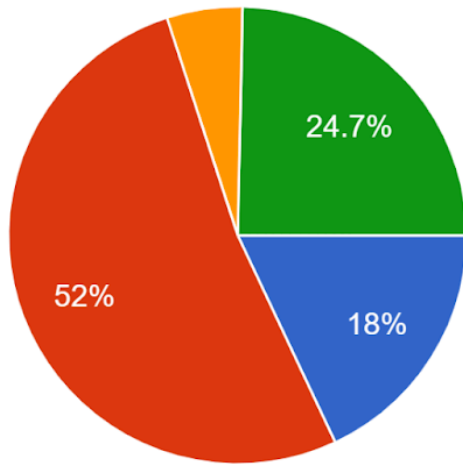
21. Are you a regular commuter or occasional user of the Long Island Rail Road (LIRR)?



22. In February 2023, the Long Island Rail Road (LIRR) instituted a new schedule. Did you like the changes made to the LIRR schedule?

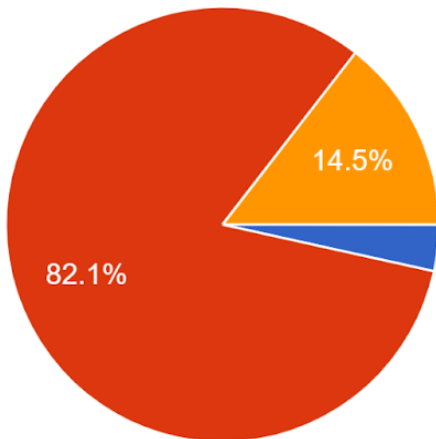


23. If the NICE Bus System were free, would you be more likely to use it for your transportation needs?



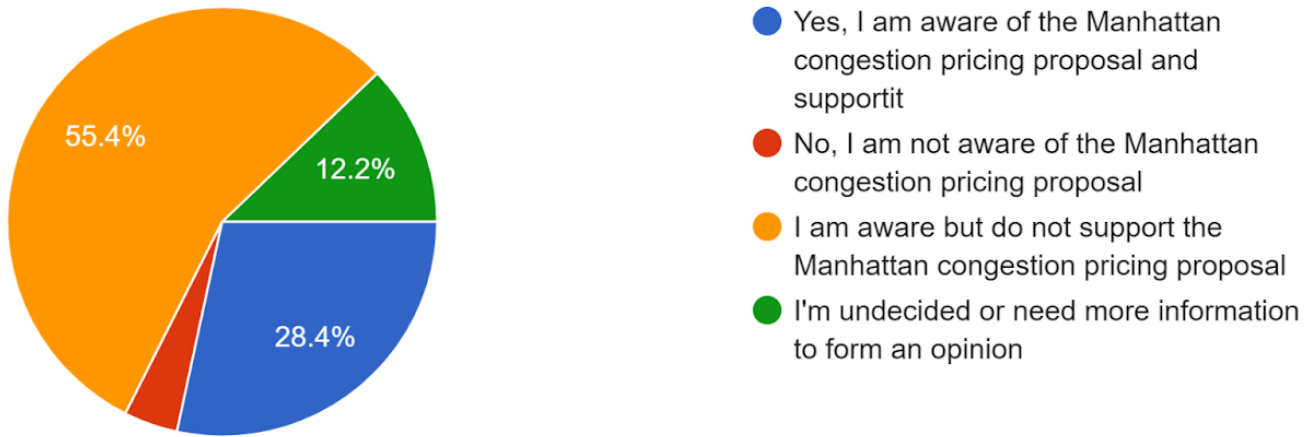

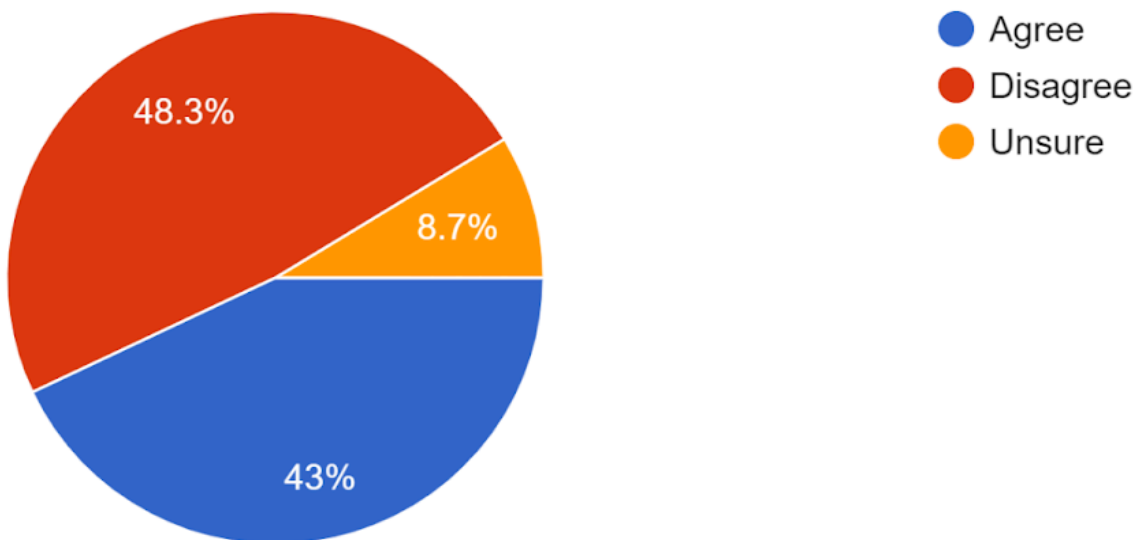
