Furthermore, my colleagues and I worked tirelessly during the 2024 state legislative session to pass essential laws and allocate resources to support our families, communities, and small businesses.

Here are some of the highlights of priority initiatives I supported in the 2024 budget:

- The New York State 2024 enacted budget provided **\$36 billion** in total for school aid, including **\$24.9 billion** in Foundation Aid
- Provides \$40 million in the Homeowner Protection Program (HOPP) to help New Yorkers at risk of foreclosure stay in their homes
- Secured funding for a **\$500 million** capital fund to develop up to 15,000 units of housing on state-owned sites across New York
- \$347 million to continue New York's efforts to reduce and prevent gun violence
- Provides \$350 million to ease the tax burdens on families through the Supplemental Empire State Child Credit.

## **Entrepreneurial Program**

I am proud to have helped provide \$10,000 in funding for this pilot program, which will serve up to 35 students in the first cohort, empowering residents and fostering upward mobility. This program is about creating opportunities, fostering innovation, and empowering our community members. I look forward to seeing its positive impact and the future business leaders it will produce. Thank you for your support and for joining us on this exciting journey toward economic growth.

#### **SUNY EOC**

\$10,000

In 2022, the Queens EOC collaborated with the Small Business Development Center at York College to develop an entrepreneurial training program for Southeast Queens. With downtown Jamaica's growth and new residents creating consumer demands, this program aims to support community members in meeting these needs by offering training in QuickBooks, business plan development, financial literacy, leadership skills, and access to the U.S. Entrepreneurship Certification Examination. To further enhance the program, the Queens EOC is participating in the 2024-25 Coalition on Adult Basic Education Online Entrepreneurship Institute, integrating entrepreneurship into adult education programs.

#### **Big Wins**

- Assemblywoman Hyndman helped secure \$830,000 in the 2024 FY Budget, \$330,000 more than last year, for sickle cell support. New York State Sickle Cell Advocacy Network Inc., a Queens-based, nonprofit community organization dedicated to servicing those in the community with sickle cell disease, thalassemia, and other chronic conditions, will be one of the recipients of funding.
- To combat the housing crisis, the state authorized New York City to establish a five-year pilot program to legalize basement and cellar apartments. As noted by many constituents and community boards, Southeast Queens can not handle more overcrowding in our neighborhoods. Assemblywoman Hyndman and other Queens Members were able to keep the Basement Pilot Program out of Queens; limiting this pilot program to the Bronx, Brooklyn, and some parts of Manhattan.
- Deed theft has been a problem for homeowners in our community and nearby areas. This year's budget defines deed theft as a crime and limits how predatory investors can take over inherited properties or pressure homeowners to sell. These new rules will help enforce the law and keep New Yorkers in their homes. Additionally, the Governor has introduced a Transfer on Death Deed, allowing homeowners to ensure their homes are protected after they pass away without needing a formal will.
- Earlier this year, Gov. Kathy Hochul pledged to address the ongoing issues of the illegal smoke shops that have been sprouting up around the State. In this year's budget, we have authorized OCM and local authorities to shut down illicit storefronts that are selling illicit cannabis. Additionally, businesses caught selling or possessing illicit cannabis risk losing their tobacco, liquor, or gaming licenses. On Merrick Boulevard alone, the number of smoke shops is overwhelming, and Assemblywoman Hyndman is pleased she and her colleagues are taking the proper steps to fix the problem and protect the community.
- The Tuition Assistance Program (TAP) will provide an additional \$55.7 million to increase the TAP income limit threshold in this year's 2024 enacted budget. The plan will also raise the minimum TAP award from \$500 to \$1,000 and expand part-time TAP to proprietary college students.

## **Asylum Seekers**

If you are a newly arrived asylum seeker, you can get free and confidential help accessing services and resources that will help you integrate into New York City. Walk-ins are now accepted Monday through Thursday on a first come first serve basis at the American Red Cross located at 520 West 49th Street, New York, NY 10019. At the appointment, you will have a fully confidential interview in your native language of preference with a trained case manager. The case manager will help identify your needs and connect you to the services, and resources available.

In 2020, I was honored to be the sponsor of legislation to make Juneteenth a state holiday in New York. For the first time in 2021, in conjunction with my colleagues in government, we celebrated our Juneteenth event "Juneteenth in Queens". On June 17, 2021, President Joe Biden signed a bill into law that officially designated Juneteenth, observed on June 19th, as a federal holiday in the United States.

2024 marks the fourth year for Juneteenth in Queens! I want to thank Tunisa Morrison and Elmcor Youth and Adult Activities, Inc. for the continued support and always making sure this event is a success. The lead-up to the celebration of Juneteenth starts with a weeklong virtual Educational Series to engage the community with topics covering Education, Environmental Justice, Housing, Policing Culture, and Generational Equity. The Juneteenth in Queens event was held in our South East Queens jewel, Roy Wilkins Park and catered to upholding black entrepreneurs and excellence. I was pleased to be joined by local elected officials such as Councilwoman Nantasha Williams, Councilwoman Selvena Brooks-Powers, Speaker of the New York City Council Adrienne Adams, New York City Comptroller Brad Landar, Queens Borough President Donovan Richards, Assemblymember Weprin, Assemblymember Anderson, Senator Leroy Comrie, Senator James Sanders, and Governor Kathy Hochul.

# New York Police Department Scam Awareness and Fraud Protection

- Scams and fraud have been on the rise. Scammers are finding innovative ways to deceive and manipulate the community. To protect against financial loss, here are some tips to stay aware:
- If you receive a phone call, email, or text message to purchase a prepaid gift card, cryptocurrency, bank wire transfer, or money to pay a public or private agency this is a scam! You can hang up and block the number from contacting you.
- Check washing is a process in which scammers use common household products to alter checks they have stolen to make the check payable to themselves or other parties. To prevent check washing, use permanent ink, as it is harder to alter, shred voided and incorrect checks, and check your bank account frequently to ensure checks were cleared by the establishment they were written for.
- Vehicles are frequently stolen for parts, insurance fraud, retagging, exporting, and joyriding. To prevent theft and damage to your vehicle: always lock and secure your vehicle, never leave your keys and property unattended in public view, and always park in high-traffic, well-lit areas.
