## Dear Friends,

This year is a critical year as Article 15-A of the Executive Law, "participation by minority group members and women with respect to state contracts," expires on December 31, 2017. This statute provides the framework for the MWBE certification

and procurement program, and establishes targeted goals for sourcing of services and commodities by certified MWBE businesses is scheduled to expire. The findings of the disparity study will continue to inform the statute. As Chair of the Subcommittee on the Oversight of Minority- and Women-Owned Business Enterprises, I will be working closely with my colleagues in government and the executive branch to ensure that the study is delivered on time. Some highlights of how strides for MWBEs have been made throughout New York State are:

- Both the City and State announced the launch of new loan funds to help MWBEs gain access to capital and grow their million announced by Empire State Development (ESD);
- A more streamlined application for M/WBE certification and a separate, more accessible and user-friendly M/WBE certification application for small businesses owned and operated by sole proprietors;
- The New York City Economic Development Corporation (NYCEDC) awarding nearly \$80 million in projects to
- The NYS Surety Bond Assistance Program (NYSBAP) which provides technical and financial assistance to help

Though we have made great strides, there is still much to be done on a statewide level.
