A Message from Jo Anne...

State Education Department Issues New Guidance to Schools on Dyslexia! What a great way to start the new school year off right: I'm thrilled to announce that the long-awaited Dyslexia guidance memorandum for school districts has been issued! This guidance was required pursuant to my legislation (<u>A.8262/S.6581</u>) and the advocacy efforts of many people across the state.

The New York State Education Department recently issued the new guidance documents on dyslexia and other learning disabilities. This will help more children learn to read and be successful students because when children's learning disabilities are clearly defined, educational interventions can be tailored to their needs and educators will be in a better position to teach them. The memorandum, created in cooperation with stakeholders, clarifies that school districts may use the terms dyslexia, dysgraphia, and dyscalculia in evaluations, eligibility determinations, or in developing an individualized education program (IEP).

School Zone Speed Safety Cameras Are Back On! Government works best when it works together. School speed cameras had gone dark over the summer because of the expiration of state authorization. While the Assembly passed legislation that I cosponsored that would have re-authorized and expanded the cameras (A7798 Glick), the Senate refused to act. Fortunately, cameras were reactivated in time for the first day of school because of an executive order crafted by the Governor and legislation passed by the City Council and the Mayor. This was also largely due to the advocates at Transportation Alternatives and the brave members of Families for Safe Streets, who have their turned indescribable losses into action to save lives.

However, the city measure is merely a stop gap, and I will continue call for the Senate to pass long-term legislation to keep our children safe. - In Person Registration: October 12th
- Change of Address: October 17th
- <u>Absentee Ballot</u>: Postmark <u>application</u> by October 30th or apply in-person by November 5th. Postmark the <u>ballot</u> by November 5th (received by November 19th). Deliver in-person ballot by November 6th (someone other than voter).

Brooklyn House of Detention (BHOD) Public Scoping Session, 9/20. The NYC Department of Correction (DOC) recently released a <u>Draft Scope of Work for a borough based jail system</u>. The proposed project will include expanding the BHOD and adding support space for correctional programming and therapeutic services, community space, and parking. I know that my constituents are committed to working with the City to ensure that the BHOD is part of a jail system that is smaller, safer, and fairer, and I joined the neighborhood walk in August to ensure that our voices are heard in the process. Unfortunately, thus far the City has not engaged with the community to the extent desired. That is why I urge you to attend the Public Session on Sept. 20 at P.S. 133, 610 Baltic St. at 6pm. Underwood announced a clergy abuse hotline and online complaint form through which victims and anyone with information can call; 1-800-771-7755. Or, you can file a complaint online at <u>ag.ny.gov/ClergyAbuse</u>. An investigator will review all allegations; the Attorney General and law enforcement partners will seek to protect victims' and witnesses' identities. As a cosponsor of the Child Victims Act (<u>A05885</u>), I am so glad that the Attorney General has created this tool to help victims of abuse, and I stand with her calling on the Legislature to pass the Child Victims Act this year (the Assembly has passed this bill, while the Senate has not).

<u>New Policies on Smoking in Residential Buildings.</u> NYC residential buildings with 3 or more units are now required to create a policy on smoking within residential units.
