Two Seawright Bills Reported to Ways and Means Committee

Waste Transfer Station Bill

Assembly Member Rebecca Seawright introduced Assembly bill 7214 last month, which requires the New York State Department of Health to conduct a study of the incidence of asthma in the Borough of Manhattan. The bill was reported out of the Health Committee to the Ways and Means Committee this week.

*"The 91st Street Waste Transfer Station in our residential community poses concerns over the impacts on public health and quality of life," **Assembly Member Seawright** said. "Air quality continues to be one of the most important and pressing issues. According to the New York City Department of Health, the community surrounding the 91st Street Marine Transfer Station has disproportionately higher rates of asthma. It is absolutely unacceptable that there is no plan to date to remediate the ill effects of such a facility. I have introduced Assembly bill 7214 which requires the New York State Department of Health to conduct a study of the incidence of asthma in the Borough of Manhattan. We must continue to fight to preserve the quality of life, safety of our streets and health in our neighborhood."*

Roosevelt Island Operating Corporation CEO Residency

Bill

This bill is an amendment to the law dating back to 1984 and requires the Chief Executive Officer of the Roosevelt Island Operating Corporation to be a resident of Roosevelt Island, or to become a resident within one year of the date of appointment. The bill moved from the Corporations, Authorities, and Commissions Committee to the Ways and Means Committee this week.

*"Roosevelt Island residents are deeply committed to their community but very disenchanted with its present governance," **Seawright** said. "Presently, there are no residency requirements for RIOC board directors or for the President/Chief Executive Officer, who are entrusted with daily life operations on Roosevelt Island. This bill allows the board to appoint the CEO of RIOC, determine the term of office and requires that the CEO complies with the rules that apply to public officers. It is a pivotal step towards self-governance for Roosevelt Island residents, creating accountability and requiring greater transparency."*

Congratulations to our Legislative Intern Matt Jansen on Winning the Assembly Mock Session Award for Excellence in Research!



Matt's research paper was one of the main components of his Assembly internship. Students were required to study a controversial issue and write an objective paper on it.

"Keeping in mind Assembly Member Seawright's priorities, I did my research on the Reproductive Health Act, A1748, which was introduced by Assembly Member Glick and would update New York's archaic abortion laws," Matt said.

The laws were written in 1970, three years before Roe v. Wade, so it does not provide exceptions for late term abortions in the event of a mother's health being at risk. The Intern Program has about 150 students. Only 16 papers are nominated, and only eight are actually chosen to be in the Distinguished Intern Report Book published by the Assembly.

Legislation to Protect and Support Victims of Domestic Violence

On Tuesday, May 9, Assembly Member Seawright announced that she helped pass legislation to address domestic violence and provide increased assistance and protection for victims as they seek justice and rebuild their lives.

The package contains the Domestic Violence Escalation Prevention Act, which prevents certain perpetrators of domestic violence from owning a firearm (A.5025). To further keep guns out of the hands of these criminals, an additional measure requires convicted abusers to surrender their firearms, closing a potentially deadly loophole in state penal law (A.980). While individuals convicted of domestic violence felonies are prohibited from owning guns, current law doesn't apply to those convicted of misdemeanor crimes of domestic violence.

"Partnership and companionship between two people should always be marked by respect, safety and understanding, and victims of domestic violence and sexual assault should know that they are never alone," said **Seawright**.

Seawright Co-Sponsors Conservation Amendment, Pet

Rescue Awareness Month Resolution, and Two MTA Bills to Improve Transit

Environmental Conservation Law Amendment (A.3945)

This bill introduced by Assembly Member Colton would amend the environmental conservation law to prohibit any solid waste polluter from soliciting solid waste contracts. Currently, there is no law in place to prevent violators of the pollution provisions of the ECL from making bids for public solid waste contracts. This policy would eliminate environmental violators from the solid waste removal and disposal industry who are rewarded for the violation of pollution laws.

Pet Rescue Awareness Month Resolution

Seawright signed onto Assembly Member Dean Murray's resolution memorializing Governor Cuomo to proclaim October 2017 as Pet Rescue Awareness Month in the State of New York. More than seven million animals enter shelters nationwide every year, of which 3.9 million are dogs and 3.4 million are cats. Approximately 2.7 million dogs and cats are killed every year because shelters are too full. It is vital that we provide a voice for those who cannot speak for themselves.

Free Ride Transfer Bill (A.3439)

This bill introduced by Assembly Member Dinowitz would require the MTA to allow customers two free ride transfers between any subway and bus or between busses. The transfers would have to be within two hours of the MTA redeeming a fare from a customer. As a result of closed bus and subway lines, many New Yorkers are forced to purchase two fares to make their daily commute. This financial burden of two fares should not fall onto riders, many of which already have difficulty paying for one fare.

Transportation Service Report Bill (A.3777)

This bill introduced by Assembly Member Dinowitz would direct the New York City Transit Authority and the MTA to report to the Governor and Legislature on all transportation service cuts, reductions, and eliminations since 2010. This will provide a clear picture of the service cuts in the last seven years and will highlight the extent of their impact on all New York City commuters. The report would be due by the end of 2018 and must include:

- Revenue savings compared to anticipated savings for each route
- The cost to fully restore each change
- A detailed plan for full restoration or equitable restoration of subways and busses that mitigate the impacts of the cuts and eliminations and fairly restores services through all neighborhoods and regions

Seawright attended the Bipartisan Pro-Choice Legislative Caucus Meeting to discuss the status of the Reproductive Health Act, a bill that has passed the Assembly. Senator Liz Krueger Co-founded the BPCLC with Assembly Member Ellen Jaffee. Although we are more than four decades after the Roe V. Wade decision, New York's laws have failed to keep pace with the Constitution. New York does not have a law recognizing a woman's affirmative right to make reproductive health care decisions. It continues to regulate abortion as part of the penal code rather than the public health code.

"My mentor Sarah Weddington, the attorney who successfully argued the landmark Roe v. Wade case, would be pleased to see that we are working to ensure a woman's right to choose. A woman's constitutional right to make decisions about her own body must always be protected," said Seawright.

During the BPCLC breakfast, guest speakers Danielle Castaldi-Micca, Director of Political and Government Affairs, NIRH and Katharine Bodde, Policy Counsel, NYCLU gave a status report on the Reproductive Health Act. Seawright also heard from guest speakers Erika and Garin about their experience with late-term abortion and why passing the Reproductive Health Act is imperative.

Seawright Fights to Increase Voter Turnout

Earlier this year, Assembly Member Seawright supported a measure in the state budget proposal to establish a period of early voting beginning eight days before a special, primary, or general election. Our democracy thrives when as many citizens as possible participate in the electoral process. The plan did not make it into the final budget, but now, legislation has once again been introduced to provide voters with more options, such as early voting including evening and weekend hours (A.2064), and allowing qualified New Yorkers to register to vote or update their registration from any computer, tablet, or phone (A.5382). Seawright is continuously working to bring election law reform to the forefront, and earlier this year, she introduced her own Electron Reform Package.

New MWBE Enterprise Programs

On Wednesday, May 10, the creation of two new minority and women-owned business enterprise programs was announced. A Request for Proposals has been issued for the creation of the MWBE Business Growth Accelerator and Certification Assistance programs, which are designed to increase capacity and ensure MWBE participation in State contracting. The new initiatives will support the growth and momentum of MWBEs across the state, and will be overseen by Empire State Development's Division of Minority and Women's Business Development.




