Join us this evening for our virtual town Hall. **We will discuss cyber security and scam prevention to address breaches of security and scams which may arise during the COVID19 pandemic.** The meeting will be hosted on zoom with an option to join by telephone for those who may not have computer access. This week, on April 22, we celebrate Earth Day! In the Assembly, as a proponent for our environment, I serve on the Environmental legislators caucus and have earned 100% rating on the Environmental Scorecard with the League of Conservation Voters. One of my first bills to be signed was the clean waterways fund. Our office has awarded grants funding dedicated to the monitoring of air quality surrounding the East 91st Street waste transfer station and to restore our beloved East River Esplanade.

As we are all pausing our lives to promote public health, take a moment to reflect on the ways in which you can do your part in protecting our planet. ***In simple conservation of resources like paper products, water, fuel and energy during quarantine, we can make a positive change toward a greener, more sustainable future. Take a look at some of the tips from the New York League of Conservation Voters on ways to reduce, reuse and recycle.***

There is a strong link between economic activity and global carbon dioxide emissions, due to the dominance of fossil fuel sources of energy. Since the coronavirus pandemic, we have seen the news and viral social media of our air and water clearing. A slowdown of carbon dioxide emissions due to reduced energy consumption is to thank for these changes. It is proof that we have the power to turn the tide on global climate change.

I am proud to support the following environmental measures:

- *The New York State Climate Leadership and Community Protection Act (Ch. 106 of 2019)*
- *A9832 - Declares the goal of the state of New York to source reduce, reuse, recycle, or compost no less than eighty-five percent of the solid waste generated by the year 2030*
- *A9842 - Bans permits from being issued for building or expanding of solid waste management facilities within one mile of schools*
- *A9865 - Relates to prohibiting a municipal corporation from applying pesticides to any playgrounds, turf, athletic or playing fields.*


