'We Will Not be Intimidated': Seawright on Anti-Semitic Graffiti



On the morning of August 11, 2020, upon opening our office we discovered vandalism and a hate filled, anti-Semitic note at our doorstep. We were later joined by prominent interfaith leaders to decry any acts of intolerance in our community at a press conference in front of our district office.

Seawright stated, "We will never be intimidated by this criminal act. We have called for a hate crimes investigation. We stand before you today to denounce this disgraceful and hateful crime. We will remain vigilant."

The incident is under investigation by the NYPD Hate Crimes Unit.

ECONOMIC IMPACT PAYMENTS

On March 27, 2020, Congress passed the CARES act to help individuals that are negatively impacted by the coronavirus epidemic. An important component of individual relief, Economic Impact Payments, are distributed by the IRS.

If you were not required to file a 2018 or 2019 federal return, or did not provide direct deposit information on either return, you may use the IRS get my payment tool to provide direct deposit information, if they have not already sent your payment: www.irs.gov/coronavirus/get-my-payment.

Seawright Cosponsors Emergency Rent Relief Act of 2020

Assembly Member Seawright is proud to have cosponsored and strongly supported emergency legislation to protect tenants and homeowners:

- A.10522 to enact the "Emergency Rent Relief Act of 2020" to establish an interim residential rent relief program for lowincome tenants.
- A.10351B to require New York State regulated banking institutions to grant 180 days of mortgage forbearance, with the option for an additional 180 days, on a residential mortgage on their primary residence to any mortgagor who can demonstrate financial hardship as a result of the COVID-19 pandemic.
- A.10252A to permit municipalities to defer certain property taxes during the COVID-19 State of Emergency and permit installment payments to be determined by the local legislative body. No additional interest or penalties will accrue during such deferment.
- A.10521 to prohibit a utility corporation or municipality from terminating or disconnecting services to any residential customer for the nonpayment of an overdue charge for the duration of the COVID-19 State of Emergency. This moratorium will last 180 days from the expiration of the COVID-19 State of Emergency for those residential customers that have experienced a change in financial circumstances.

Seawright Advocated for the Rent Guidelines Board Decision to Approve a Rent Freeze for Rent-Stabilized Apartments in NYC

The RGB passed the proposal by a 6-3 vote. Rents are now frozen on one-year leases and the first year of two-year leases. During the second year of two-year agreements, landlords can bump rent up 1%. The changes will go into effect for leases beginning between October 1 and September 30, 2021.

Tele-Health: Keeping Healthy During Quarantine

In response to the critical need to keep in touch with physicians during quarantine, Seawright cosponsored Assembly Bill 10404A to ensure audio-only and videoonly telehealth and telemedicine services will be eligible for reimbursement. This legislation addresses cases in which individuals may not have access to a webcam but still receive care over the telephone and need to be covered.

Seawright Cosponsors and Passes Ballot Access Legislative Package

Ballot access is central to our democracy and we must hold the Board of Elections accountable in doing their part to educate voters, simplify the processes of voting including requests for absentee ballots, and the accurate count and validation of those ballots submitted by mail. Voting is one of the most fundamental rights we have as citizens and is essential to our democracy, and therefore, must be protected at all costs.

Our office has been working on reforming our election processes. The Governor signed my Assembly Bill 9001 to save taxpayer resources and to promote efficiency and transparency by allowing candidates to duly satisfy local and state requirements in order to run for office. We strongly supported the Executive Order by Governor Cuomo expanding voting by mail during the pandemic to ensure that voting could still take place with safety in mind. Seawright is a proponent for the registration and tracking of absentee ballots to ensure that every vote counts.

Protecting Vulnerable Nursing Home Residents

Assembly Member Rebecca Seawright cosponsored legislation to establish a nursing homes "annual pandemic emergency plan" which will include protocols for:

- Communicating the status of each nursing home resident to family members
- Protecting patients, staff, and visitors from infection
- Ensuring hospitalized residents be cleared of infection before readmission to the facility
- Preserving a resident's place in the facility if they have been hospitalized
- Ensuring the facility maintains at least a two-month supply of personal protective equipment.

In our community, Seawright advocated for our district's Coler Hospital on Roosevelt Island by holding a press conference to spotlight COVID-19 response at Coler and to distribute life-saving personal protection equipment (PPEs) to staff. She also co-hosted a meeting with patients, advocates, elected officials, and the city's Health + Hospitals leadership to get answers about Coler's patient care during the crisis. As a result, a new community-based task force has been established to monitor operations at Coler, including COVID-19 testing and related protocols. Our advocacy for Coler Hospital residents on Roosevelt Island continues.

Additionally, Seawright is proud to cosponsor and strongly support the following measures passed by the Assembly this session:

Automatic Voter Registration - would allow state and local agencies to provide the New York State Board of Elections with voter registration information for people that submit an application for services or assistance.

Legislation to promote the timely use of absentee ballots during the COVID-19 pandemic:

- Assuring voters concerned about the transmission of COVID-19 that they may obtain an absentee ballot (A.10833)
- Allowing applications for absentee ballots to be processed earlier than 30 days before the election, as provided by current law (A.10807)
- Imposing a presumption that an absentee ballot envelope without a postmark is timely if it is received at the board of elections by mail the day after the election (A.10808-A)
- Allowing a number of current defects on an absentee ballot envelope to be timely "cured" by a voter after notice from the board of elections (A.10830)

will either appear on caller ID as "Test and Trace," or a 212 number. Contact tracers will never ask for your Social Security number, your immigration status, any private financial information, or a credit card number.

Beat the Heat With HEAP Assistance • The Home Energy Assistance Program (HEAP) is a federally funded program that helps low-income homeowners and renters pay for utility and heating bills.

If you have received an electric, gas, or heating disconnect notice, you can apply for emergency financial help. You may also qualify for help if you have a low supply of heating fuel or a broken boiler or furnace. Active SNAP/Cash Assistance clients and clients receiving SSI who live alone are automatically eligible for HEAP benefits. For more information on HEAP, contact the Manhattan Department of Social Services at 212-331-3126.

Additionally, families and individuals who meet certain criteria can apply for the Utility Assistance Program (UAP) for financial assistance to help pay their energy bills. If you meet the requirements for UAP, contact 212-331-3150.

Con Edison • As a reminder, Con Edison will not be shutting off anyone's power for failure to pay during this pandemic. If your bill is more than you can pay right now, you may be able to arrange a flexible payment agreement by calling 1-800-75-CONED (1-800-752-6633).

Department of Motor Vehicles • On July 6th, limited in-person transactions began at DMV locations across New York City. Driver licenses, non-driver

identification cards and vehicle registration that expired on or after March 1, 2020 were extended, along with vehicle inspections that expired on March 31, 2020. Alexander "Pete" Grannis shared information on how to claim your unclaimed funds by calling 1-800-221-9311. New York State's Abandoned Property Law requires certain entities to transfer



abandoned money or securities to the New York State Comptroller's Office of Unclaimed Funds. Unclaimed funds can include, for example, banks, insurance companies, corporations, and state agencies. The funds come from inactive bank accounts, uncollected insurance policies or refunds, amounts due for undelivered goods or services, abandoned stocks, uncashed checks and more.
