Today, on International Human Rights Day, I was on Roosevelt Island for the unveiling of "The Girl Puzzle Monument Honoring Nellie Bly," at Lighthouse Park. Nellie Bly was a courageous journalist who, through her writing, took on the people and institutions that violated human rights.

Together with over 30 of my Assembly colleagues, I called upon the SUNY Board of Trustees to terminate the Chancellorship of James Malatras and to appoint an interim replacement until a national search can be conducted which will be open to all qualified candidates including women and people of color. The following day the Chancellor resigned effective January 14.

Seawright Leads Sign-On Letter to Terminate the Chancellorship of James Malatras



SUNY boss Malatras must go 31 Assembly pols say

"We, the undersigned members of the New York State Assembly, call upon the Board of Trustees of The State University of New York to terminate the Chancellorship of James Malatras

On Wednesday, December 8 more than 30 members of the New York State Assembly have written to the Board of Trustees of the State University of New York demanding the firing of Chancellor James Malatras.

In a letter dated Dec. 8th to SUNY Chair Merryl Tisch, Vice Chair Cesar Perales, and the board, the Assemblymembers declared that Chancellor Malatras' recently released statements are "misogynistic, abusive, and irresponsible...Chancellor Malatras has lost our confidence that he has the credibility or the character to lead the nation's largest public university," the group added.

They urged Chair Tisch and the board to immediately name an interim chancellor and begin the process of a national search "open to all qualified candidates including women and people of color."

On Thursday, December 9, Chancellor Malatras resigned effective January 14.

Seawright Delivers Remarks at the Unveiling of the Nellie Bly Monument




Seawright said, "Nellie Bly is not only a monumental Roosevelt Island Historical figure, she was one of the foremost courageous female journalists in the US. It was her boldness, curiosity and independent spirit that set her apart to uncover injustices in our society.

Thank you to the Selection Committee for this amazing public art project including Roosevelt Island's Historian and President of the Historical Society Judy Berdy. You keep the stories of Nellie Bly on this island in our hearts and minds! It is fitting that on International Human Rights Day, we celebrate a woman who took on people and institutions that violated human rights. Right here on Roosevelt Island in 1887 Nellie Bly documented her experience when she feigned mental illness to uncover truth about the women's asylum in a work called ten days in an asylum.

Today we unveil five diverse women's faces in bronze known as the girl puzzle -- Asian American, Black, young, old, and gueer women.

COVID-19 Updates

New York Launches First-in-the-Nation \$539 Million Homeowner Assistance Fund to Assist Eligible New Yorkers at Risk of Foreclosure or Displacement



Help is on the way! Homeowners, including those living in condos and co-ops, can soon apply for essential financial relief. The NYS HAF offers a wide range of services for eligible homeowners such as financial support to address missed housing-related payments. Supplemental Nutrition Assistance Program Changes

SNAP is an essential program that puts food on tables and helps families make ends meet.

Now, New York State is making it easier for older adults and people with disabilities to access SNAP.

SNAP benefits are a lifeline for New York families. New changes include providing a simplified one-page application form, allowing older New Yorkers to recertify their benefits for 36 months instead of 24 months and eliminating the interview requirement for recertification. Additional COVID-19 Related Updates

New Yorkers who are 18 and older can get their COVID-19 booster dose. This includes individuals who received their Pfizer-BioNTech or Moderna initial vaccine series at least six months ago or the Janssen/Johnson & Johnson COVID-19 vaccine at least two months ago. New Yorkers may feel at increased risk of COVID-19 because of their occupational or institutional setting — meaning where they work or live. Individuals who have questions about their risk are encouraged to consult with their primary health care providers.

The CDC has approved the Pfizer COVID-19 vaccine for children ages 5-11 and it's free for everyone. Together we can all do our part to stay healthy and protect ourselves and those around us. Visit www.covid19vaccine.health.ny.gov to learn more.
