Dear Friends and Neighbors,

We will continue voting tonight to approve a budget that prioritizes New York's economic recovery and addresses rising costs. A budget agreement has been made including unprecedented investments in childcare and prekindergarten to help parents and caregivers. Additionally, the budget promises a meaningful wage increase for homecare workers for the critical work that they do to ensure New Yorkers can live comfortably and with dignity in their homes. We fought and delivered for higher education to be more affordable for more families, doubling investments in higher education opportunity programs since 2015. To ensure students can thrive in the classroom, the budget agreement makes record investments to ensure that students are safely returning to the classroom for a high quality public education.

History was made this week as Justice Ketanji Brown Jackson was confirmed with bipartisan support to be the 116th Associate Justice of the U.S. Supreme Court and is now the first Black woman to serve on the Court. Justice Jackson is eminently qualified for this role, with a robust judicial record and many years of experience on the federal bench. She is the only member of the Supreme Court to have served as a public defender and vice chair of the U.S. Sentencing Commission. Supreme Court Justice Ketanji Brown Jackson is truly an inspiration to many.

This week, we held a clinic for the COVID-19 second shot booster. We are hosting another clinic this week on Tuesday April 12.


