Seawright Rallies With Disabilities Advocates For 8.5% Cost Of Living Adjustment In The Final Budget





Chair of the People With Disabilities Committee, Assembly Member Seawright kicked off the rally by saying, "With your help we can keep this level of support in the adopted budget. After years of neglect for this vital system, we are here to demand respect!"



Hundreds of disability advocates from across New York State filled the Legislative Office Building for a Statewide rally calling on Governor Hochul and the State Legislature to include the full 8.5% COLA and make the inclusion of the COLA automatic year after year in the FY24 Final Enacted State Budget.

The results of a recent New York Disability Advocates survey found that direct support positions remain at nearly 20% vacancy statewide which equals up to 19,788 vacancies that need to be filled by the not-for-profit sector. Additionally, the annual turnover rate for provider agencies statewide is at a staggering 30%, costing provider agencies \$100.5 million annually. This cost directly inhibits funding essential supports and services for New Yorkers with I/DD, and lack of quality staff has left thousands of New Yorkers with I/DD and their families without access to much-needed care. Unfortunately, without adequate funding to offer competitive wages, agencies cannot recruit and retain staff to build a sustainable I/DD service system.





#### **Construction Updates**

#### MTA 63 Street Track Replacement Project

MTA is revising its schedule for the replacement of its direct fixation track along the 63rd Street corridor, which is used by the F line to travel between Manhattan and Queens via Roosevelt Island and the 63rd Street Tunnel.

Last month MTA informed the ridership that a critical state of good repair track work would begin May 1, 2023 and proceed in three consecutive phases through October 2023.

MTA reports they are coordinating closely with a concurrent project to upgrade the signal system along the Queens Boulevard Line to Communications-Based Train Control (CBTC) and are **reevaluating the start date and overall schedule of the direct fixation track work** in coordination with several other projects along the Queens Boulevard Line and other subway lines.

At this time there is no revised schedule for the 63rd Street line track work. It will not start before July 1, 2023, and due to other scheduling factors, the start may be pushed to 2024.
