This past week we remembered the heroes of 9/11, and those who we have lost since then of 9/11-related illnesses. I was honored to participate in a commemoration in Carl Schurz Park remembering the solemn day and what it means to New Yorkers.

As Chair of the People with Disabilities Committee, I am proud to report that this week two of my bills have been signed by Governor Hochul to support people with disabilities. Assembly Bill 6543 renames the Developmental Disabilities Planning Council to be the State Council on Developmental Disabilities and provides substantially more appointments of members with disabilities to the council and A.5879 which will replace outdated and harmful terminology in reference to people living with intellectual disabilities. By substituting outdated and degrading phrases with people-first language, "developmentally disabled" and "developmental disability" will be used throughout our laws, New York will take a meaningful step toward encouraging inclusion, acceptance, and respect for people living with intellectual disabilities across our state and nation.

Seawright Bills To Support People With Disabilities Signed by Governor Hochul

## New Laws Focus on People-First Policy

Chair of the People with Disabilities Committee, Assembly Member Rebecca Seawright announced that Governor Kathy Hochul has signed two of her pieces of legislation. The first bill increases representation of people with disabilities on our State's planning council and changes the name of the Developmental Disabilities Planning Council (DDPC) to the State Council on Developmental Disabilities, updating the language in the law to comply with federal requirements for "person-first" language (A6543). The second bill amends our state statutes by updating the outdated and offensive language "mentally retarded" to "developmental disability" (A5879A).

"It is important to all of us and the State of New York that we remain up to date and

respectful of individuals at all times," Governor Hochul said. "This legislative package will allow changes to outdated language in our State laws and continues our efforts to help strengthen the rights of all New Yorkers."

"I commend Governor Hochul for signing our bills to promote inclusion, dignity, and respect for New Yorkers living with disabilities. Through the governor's action, together with the State Legislature, we are most substantially increasing representation of people with disabilities on our State's planning council and renaming the 'Disabilities Planning Council' to the 'State Council on Developmental Disabilities,' implementing person-first language to put the person before their disability," said Assembly Member Rebecca Seawright, Chair of the People with Disabilities Committee.

"We are also updating the outdated and offensive language "mentally retarded" to "developmental disability." These changes are a huge step in the right direction for achieving full equality for New Yorkers with disabilities," continued Chair Seawright.

## Seawright Urges DOT Commissioner To Scrap Cargo Bike Proposal

Assembly Member Rebecca Seawright wrote to the Commissioner of the New York City Department of Transportation Ydanis Rodriguez, expressing concern about the proposal to allow larger and potentially more dangerous vehicles onto our bike lanes without addressing more pressing issues surrounding enforcement of existing traffic laws. "I implore you to maintain the current rules, to not allow the addition of 'Pedal-Assist Commercial Bicycles' and to increase enforcement in the bike lanes" urged the Assembly Member in her letter.


