This week in Albany, Governor Hochul addressed the Legislature with her State of the State, outlining proposals that will guide our budgetary and legislative work this session. In this special report, I share my response to the Governor's proposal to expand rent freeze protections for New York City seniors and people with disabilities—a critical step toward helping more New Yorkers remain safely in their homes. We also include key takeaways from the Governor's 2026 State of the State address, highlighting priorities that affect affordability, public safety, education, energy, and the protection of our communities.

This past weekend, we saw an incredible turnout at our paper Shred-A-Thon, where neighbors safely disposed of nearly three tons of sensitive documents. Due to the overwhelming demand, we are committed to planning additional shredding events in the future.

It was also a pleasure to present a citation recognizing Coach Ryan Martin, head coach of the CUNY Adaptive Sports Wheelchair Basketball team. His dedication to creating inclusive opportunities for all New Yorkers is truly commendable.

We have heard from many constituents seeking information about how to respond to and resist illegal ICE actions in our community. Hands Off NYC, a grassroots coalition working to protect immigrant communities, is hosting Upper East Side trainings to help neighbors stay informed, prepared, and connected during these uncertain times.

On Monday, January 19, we honor the life, legacy, and vision of Dr. Martin Luther King Jr., a tireless advocate for justice, equality, and opportunity for all. Dr. King's courage reminds us that progress is achieved through action—by standing up for the marginalized, lifting our communities, and working toward a more just and inclusive society. As we reflect on his enduring message, let us recommit to carrying forward his dream and building a New York where every person can live with dignity, safety, and hope. Please note that our district community office will be closed on Monday, January 19, in observance of this federal holiday and will reopen on Tuesday, January 20 at 9:30 a.m.

**Statement on State of the State Proposal Expanding Rent Freeze Protections for New York City Seniors and People with Disabilities**

# Raising NYC's SCRIE & DRIE income limit to \$75,000

More seniors and people  
with disabilities will stay in  
their homes and avoid  
displacement



Governor Hochul has proposed raising the income eligibility for New York City's rent freeze programs to \$75,000, expanding access to the Senior Citizen Rent Increase Exemption (SCRIE) and Disability Rent Increase Exemption (DRIE). This long-overdue update will help more seniors and people with disabilities stay in their homes amid rising housing costs.

Nearly 1.5 million older adults live in New York City, and many face economic insecurity. Updating the income cap from \$50,000 to \$75,000 reflects today's cost of living, allowing thousands more to age in place with dignity.

***"Rent freeze programs are often the only thing standing between New York City's most vulnerable residents and homelessness,"*** said Assembly Member Rebecca Seawright, Chair of the Assembly Aging Committee.

Governor Hochul's State of the State also includes investments in NORCs, in-home services, the CAPABLE program, hospice and palliative care, and protections against elder abuse, scams, and fraud—helping seniors live safely and independently in their own homes.

**Governor Delivers 2026 State of the State: "The State of Our State is Strong"**



Governor Kathy Hochul delivered the 2026 State of the State address, highlighting New York's resilience, growth, and bold vision for the future. Reflecting on the state's 250-year history, the Governor celebrated New Yorkers' enduring strength and commitment to liberty while outlining achievements and priorities for the year ahead.

Key highlights include:

- Affordable Living & Families: Expanding child care, capping insulin costs, launching the nation's first paid prenatal leave, and investing in housing to help families put down roots.
- Public Safety & Crime: Record-low crime rates, strengthened gun laws, enhanced police patrols, and new protections against 3-D printed ghost guns.
- Education & Workforce: Free community college for adult learners, new math and reading initiatives, and workforce development in high-demand fields.
- Economic Growth & Jobs: Historic investments in clean energy, advanced technology, and manufacturing; major projects including Micron, GlobalFoundries, and the Interborough Express.
- Energy & Sustainability: Expanding clean energy, nuclear power, and utility assistance programs to make energy affordable and reliable.
- Protecting Rights & Communities: Safeguarding reproductive rights, combating antisemitism and Islamophobia, regulating social media for youth, and holding federal ICE accountable.

The Governor emphasized that, despite federal challenges and rising costs, New Yorkers' determination and ingenuity will continue to drive progress. "The State of our State is strong, and we're just getting started," the Governor declared.


