### Statement by Assembly Member Rebecca A. Seawright on Recent Acts of Antisemitic Violence

"I am deeply saddened and outraged by the recent acts of violence targeting the Jewish community, including the brutal attack on Jews celebrating Hanukkah at Bondi Beach in Sydney and the shooting at Brown University. These horrific incidents underscore the very real and growing threat of antisemitism, here in the United States and around the world.

The Bondi Beach attack, which claimed the lives of fifteen people—including a child and a Holocaust survivor—struck at the heart of Hanukkah. This holiday symbolizes the Jewish people's enduring fight for the right to live openly and safely as Jews. The shooting at Brown University is another devastating reminder that antisemitic hatred can erupt in places meant to be centers of learning, dialogue, and community.

When Jews are targeted for simply being Jewish, it is an attack on the fundamental values of freedom, dignity, and safety that we must all defend. These acts of violence reverberate deeply within New York's Jewish community and beyond.

I stand in solidarity with Jewish communities everywhere and mourn with the families and loved ones of the victims. I also wish to recognize the extraordinary courage of Ahmed al-Ahmed, whose heroic actions at Bondi Beach saved lives.

We must continue to speak out clearly and unequivocally against antisemitism in all its forms and remain united in our commitment to ensuring that every person can live, learn, worship, and gather without fear."

## Seawright Commends Governor Hochul on Announcing Agreement on Medical Aid in Dying

Governor Kathy Hochul announced an agreement with the Legislature to make medical aid in dying available to terminally ill New Yorkers with less than six months to live. This follows months of careful deliberation with bill sponsors, advocacy organizations, and everyday New Yorkers who shared deeply personal experiences. The bill, with agreed-upon amendments, will be passed and signed in January, and the law will take effect six months later.

Assembly Member Rebecca Seawright, a strong co-sponsor and supporter of the legislation, commends Governor Hochul for her leadership in bringing this important measure to fruition. ***"This legislation provides terminally ill New Yorkers with the dignity, autonomy, and compassion they deserve at the end of life,"*** said Assembly Member Seawright.


The legislation includes important protections to ensure that patients are making voluntary, informed decisions, and that doctors and health care facilities are prepared to administer medical aid in dying responsibly. Key safeguards agreed upon include:

- A mandatory five-day waiting period between when a prescription is written and filled.
- Oral requests for medical aid in dying must be recorded by video or audio.
- A mandatory mental health evaluation by a psychologist or psychiatrist.
- Prohibiting anyone with a financial interest in the patient's death from serving as a witness or interpreter.
- Limiting access to New York residents.
- Requiring initial physician evaluations to occur in person.
- Allowing religiously-oriented home hospice providers to opt out.
- Violations of the law will be treated as professional misconduct.
- The law will take effect six months after signing, giving health care facilities time to prepare and implement necessary regulations.

This landmark legislation reflects New York's commitment to giving terminally ill residents autonomy over their final days while ensuring robust protections for patients, families, and medical professionals.

## New Minimum Wage Coming Into Effect



To help ease the financial crunch caused by the rising cost of living, the Assembly Majority helped enact a multi-year increase to the state's minimum wage. On Jan. 1, the minimum wage will increase to \$17 per hour in New York City, Long Island and Westchester County, and \$16 per hour everywhere else. We'll never stop fighting to lift up working people and make New York a more equitable, affordable place to call home.

## Help Count Our Neighbors Experiencing Homelessness HOPE Survey 2026

In January 2026, the NYC Department of Homeless Services (DHS) will conduct its annual Homeless Outreach Population Estimate (HOPE) survey, and community participation is essential.

On Tuesday, January 27, 2026, volunteers will work alongside outreach teams across all five boroughs to help count New Yorkers experiencing street homelessness. From approximately 10:00 PM to 4:00 AM, participants will canvass their own neighborhoods to help ensure the City has accurate data to better deliver services and connect vulnerable New Yorkers to safe, stable housing.


