Dear Friends,

The state budget process continued this week with further discussion within each house of the legislature in preparation for one-house budget proposals and negotiation with Governor Hochul and her team on the governor's initial executive budget proposal.

One of my priority issues is support for digital inclusion programs to provide digital literacy to individuals in need of broadband access, devices and training. I am working with advocates across the state and national experts on this important equity issue.

An important part of this effort is a statewide series of regional meetings on digital equity that will help NYS draft a digital equity plan required for the 2024 round of federal funding towards these programs. Our regional meeting, which I helped organize, will be held at SUNY Purchase on March 24. I have attached the flyer below. The sponsors are New York State's ConnectALL office and the STEMAlliance. SUNY Purchase is a great host and partner. I have attached the event flyer below. The purpose of the meeting is to hear about digital inclusion needs and solutions from:

- Regional planning and economic development organizations
- Internet service providers
- Educational institutions
- Workforce development organizations
- Non-profit organizations serving vulnerable New Yorkers

Please consider attending and helping contribute to the statewide plan. We want to bring more funding to Westchester to support these programs.

Last weekend I co-hosted two well-attended community forums with State Senator Shelley Mayer, County Executive George Latimer and County Legislator Catherine Parker. These sessions in Rye and Larchmont brought forth great questions and issues from attendees and an opportunity for the four us to provide updates on the state and county issues on which we each work.

This week I have also included information on how to comment to the NYS Public Service Commission on ConEd's proposed rate increase application and information from Governor Hochul on how to protect your personal identification information during tax season.

This weekend I will be attending the SOMOS conference in Albany and hosting a workshop focused on not-for-profits serving the Latino community in suburban and upstate communities. I am co-hosting this discussion with Assemblyman Phil Ramos of Long Island.

### Port Chester and Rye Each Receive \$10M NYS Water Quality Grants

State water infrastructure funding is an essential tool in assisting local governments as they implement needed upgrades to aging water systems. We received great news this week with word that the Village of Port Chester and the City of Rye have each been awarded \$10 M grants from the state's Water Quality Improvement Project (WQIP).

The funding will help each community implement wastewater system improvements. With these grants, both municipalities will make significant upgrades to their sewer systems. Rye's project will complete spot repairs and replacements, installing 22,000 linear feet of pipe lining and repairing 500 manhole defects city wide. The project will reduce the amount of untreated wastewater entering Long Island Sound during storm events. The Village of Port Chester is also undertaking an aggressive program of sanitary sewer repairs that, consistent with the WQIP program goal, will improve water quality in the Byram river, ground water and Long Island Sound.

These upgrades will help protect water quality in Long Island Sound. As coastal Sound Shore communities, wastewater infrastructure upgrades benefit water quality and aquatic habitat in the Sound.

Water infrastructure funding has been a major priority of mine in the State Assembly. The 2023-24 State Budget process is now underway, but Governor Hochul has already committed to another year of strong support for these clean water grant programs.

Port Chester and Rye were two of only three Westchester communities to be awarded grants in this round of funding. State Senator Shelley Mayer and I worked closely together to support these applications and the work of Port Chester and Rye to move forward on needed improvements. Hurricane Ida highlighted the importance of upgrading and improving all water infrastructure. Every community on the Sound Shore is involved in similar work.

The mission of WQIP is to fund projects that will directly improve water quality of aquatic habitats or protect a drinking water source. This funding will further the broader efforts toward preserving and protecting the aquatic habitat of Long Island Sound and continue the important work of putting the sound on a path toward a cleaner and healthier estuary.
