## Youth Advisory Board

This November, I hosted our first Youth Advisory Board meeting, which is a group I formed to connect with the next generation of leaders and learn what issues they care about most and discuss solutions. Students from high schools across the district as well as from Skidmore College and SUNY Adirondack were nominated to attend. The meeting was a resounding success and proved just how capable, intelligent and passionate our young minds are about the community and world around them. I look forward to meeting with them several more times during the school year and hearing their ideas and opinions.

## Libraries

Once again, I took a summer tour of the libraries across our community. These tours give me the opportunity to see firsthand how much kids enjoy reading as well as talk directly with librarians about the challenges they might be facing. This was especially important following COVID-19, as many libraries temporarily shut down and saw fewer visitors. But, without fail,



librarians found ways to keep people engaged with reading by heading outdoors, and I greatly admire their dedication and creativity. I also offered my Summer Reading Challenge again to kindergarten through third grade students at participating schools, which even took on a life of its own and made its way to younger and older generations of students as well.



## Food security

Food insecurity remains a concern for families and seniors across our region. I fought to secure funding in the state budget for the Comfort Food Community to expand their food hub and Pitney Meadows Community Farm to create “pop-up” food pantries. Many of these pop-ups are located near senior apartment buildings and popular gathering spots, making this healthy produce more accessible to the community. I got to see the value of this program firsthand when I visited the Malta and Mechanicville pop-ups to help pack boxes of produce.



## Important legislation

I sponsored several bills this past legislative session to help make our community a better place to live. I secured a four-year extension of a waiver our small school districts depend on to participate in the small group health insurance market, saving money for both our schools and taxpayers. To support those suffering from addiction, I sponsored a new law requiring funds from opioid settlements to go solely toward prevention, treatment and recovery programs for opioid addiction. I also sponsored a law requiring child support for dependent disabled children until age 26. Several other bills I championed are awaiting the governor’s signature, including legislation to improve broadband access, permit blood transfusions on air ambulances and include vascular rupture as a covered condition under the Volunteer Firefighters’ Benefits Law.



## Trades

As chair of the Skills Development and Career Education Commission, I’m committed to promoting the building trades as a valuable career track for young people. I participated in several events to educate individuals about these stable and well-paid jobs. This includes the Women in Trades Luncheon at the Washington County Fair and the opening of the Multi-Craft Apprenticeship Preparation Program (MAPP) in Albany, which encourages young people in minority communities to consider a career in the building trades and provides hands-on learning experiences in all trades. I’m also working with representatives from Capital Region Building Trades to set up a panel discussion in local schools highlighting successful women in all stages of their trades careers, from apprenticeship to business owner.



## Transportation

One of my top priorities has been strengthening our public transportation system. That’s why I’m pushing for the Capital District Transportation Authority (CDTA) to expand their new “FLEX” bus service program to Saratoga County. This on demand, app-based service just launched in September and helps residents in smaller communities get to where they need to go, including Albany Medical Center, Albany International Airport and other popular stops in the FLEX service area.
