Flooding

Mohawk Valley residents know the dangers and costs of widespread and increasingly frequent floods all too well. Families who own homes on a flood plain often struggle to sell their houses, even at a reduced price, or bear the burden of repeated renovation and repair projects, Over the last two years I've fought to ensure our communities receive the funding we needed to recover from extreme weather events.

The denial of funding from the Federal Emergency Management Agency (FEMA) was detrimental to our Halloween 2019 flood victims. Yet, as the world attempted to deem their property and loss as insignificant, I worked with state and federal legislators and reminded these victims that we have not forgotten them, nor had we stopped the fight.

In 2020, the U.S. Department of Agriculture Natural Resources Conservation Service (NRCS) granted a buy-out program that flood victims had been desperately waiting on.

I worked hand in hand with the Village of Whitesboro to ensure that every resident had the opportunity to fill out an application. As days grew closer to the deadline, I went door to door delivering applications and information and helped numerous constituents obtain the documentation and notarization they needed to complete their forms.

Legislation

During my first two years in office, I introduced 58 pieces of legislation and supported hundreds of bills to protect our veterans, improve our business climate, reduce government regulations and undue paperwork, strengthen public safety, support law enforcement officers and first responders, and to deal with the impacts of COVID-19.

I sponsored several pieces of legislation to help communities navigate through our pandemic in the 2019-20 Legislative Session that I have re-introduced in the 2021-22 Legislative Session. These include: a bill to offer temporary early retirement incentives for some public employees to prevent layoffs and save taxpayers money (A.10897 of 2019-20) and legislation that will criminalize catalytic convertor thefts and will require recyclers and vehicle dismantlers to document catalytic convertor sales similar to documentation requirements for pawn shops (A.11160 of 2019-20).

In order to support businesses, in 2020, the Legislature has acted on legislation which would Development require **Empire** State coordinate with all state agencies and state authorities to create a clearinghouse on its website where small businesses can easily find information on state programs (Chap. 339 of 2020). Additionally, legislation that I introduced with State Senator Rachel May (A.7104/S.3873) which would allow BOCES to establish and encourage young farmer apprentice programs to recruit farmers and protect our agriculture industry and food supply was passed in both the Assembly and Senate this July.

I will continue to advocate for any and all legislation which will protect public safety, support our community members, and build up small businesses and the Mohawk Valley's economy.

A.998 of 2021

To require the use of an antimicrobial copper alloy that is recognized by the US environmental Protection Agency for touch surfaces in new, publicly funded construction projects in order to reduce the presence of disease-causing bacteria, viruses, and yeasts on commonly used touch surfaces and therefore protect public health.

A.1027 of 2021

In United States v. Salerno (1987), the United States Supreme Court upheld preventive detention under the Eighth Amendment to the Constitution, where a defendant has been charged with a serious crime and may pose a danger to the community or an individual within it. Judges should be allowed to consider the risk a person poses in determining whether that person should be detained pending trial. That is sensible in order to protect victims of crimes, and our communities and individuals within them.

A.1172 of 2021

This bill subjects the Governor's actions during a state disaster emergency declaration to Legislative review every 30 days. This does not prevent the Governor from doing what they feel is necessary to keep the people of New York safe, but it does prevent them from circumventing the Legislature, as well as allows the people of the State of New York, through their legislative representatives, to have more of a say in how the state reconciles with a disaster affecting the State.

A.1235 of 2021

Despite an Executive Order allowing restaurants and bars to sell alcohol with takeout orders during the COVID-19 pandemic, the Governor's closure of these establishments prevented them from operating under the terms which were established between them and the State when they paid for their liquor license. This bill directs the SLA to give eligible bars and restaurants a credit on liquor license renewals in proportion to the amount of time for which they were shut down due to the pandemic.

Education



COVID-19 has placed a heavy strain on students, teachers, families, administrators and our education system. As a former educator, student success is one of my top priorities. Throughout the COVID-19 pandemic, I have remained in constant contact with those who could provide guidance on all that is occurring. I have regularly heard from and remained in contact with parents and students, teachers and administrators, the State Education Department (SED) and the Board of Regents, as well the Assembly and Senate Education Chairs, to ensure that I remain up-to-date on what is happening in our education system.

Over the past year, I have:

- Requested information and overviews on how districts should prepare to address the
 health and needs of children, teachers and staff within the schools throughout this
 crisis;
- Participated in Public Hearings hosted by the Assembly and Senate Education and Higher Education Committees to discuss the impact of the pandemic on schools, faculty and students;
- Reached out to the State Education Department (SED) and urged them to allow school districts to receive transportation aid for expenses incurred during the COVID-19 pandemic to ensure these additional operating costs did not further set back our already struggling school districts; and
- Created a virtual field trip of the New York State Capitol, hosted a bill challenge and
 offered several essay and reading incentives to help students remain engaged in
 civics.

Agriculture and Farms



During these unprecedented times, it was critical that we examined how the state was supporting our farmers. In order to access those needs I met with several farmers and sat with stakeholders to obtain firsthand knowledge about the challenges they were facing. As we examined the impact the pandemic caused on our farming businesses, I fought to get Mohawk Valley farmers the resources and assistance they need to thrive through this crisis.

- I created a Resource Directory for Farmers which can be found at www.nyassembly.gov/buttenschon.
- I pushed to authorize legislation that would increase Farm Workforce Retention Credit
- Advocated for the Marketing and Export Take–New York (MEET-NY) program to assist and encourage businesses, industrial firms and industry groups to engage in export trade regionally and globally (A.1159).
- My bill, which I created to allow Boards of Cooperative Educational Services (BOCES) to establish young farmer apprenticeship programs, was signed into law (Ch. 298 of 2020).





On Healthcare:

- Since mid-April, our healthcare workers have put their own health at risk to serve their patients. Now, with COVID-19 on the rise, one of the most critical ways we can help ensure this second wave of cases is less severe than the first is by supporting staff in our health care facilities at every turn.
- I have been a leading voice, in calling for the state to protect New York's vulnerable residents in nursing homes, which had some of the earliest and deadliest outbreaks of COVID-19, as well as in our hospital facilities, and I do not plan to quit anytime soon.
- I've called upon the governor and state to protect nursing homes from experiencing outbreaks of the virus.
- I pushed to have all stakeholders be part of the discussion on how to improve and effectively respond to COVID-19.
- I attended multiple state Legislature joint public hearings to discuss the impacts that COVID-19 had on residential health care facilities
- I joined my fellow legislators and concerned residents of the 119th district and marched in Albany for the Take Back Our Nursing Homes rally.
- Many of our healthcare facilities have faced recruitment and retention issues for several years, and the ongoing pandemic has only further strained their resources and capabilities.
- It is my intention to work with my fellow legislators to make sure the necessary resources are set in place in times of crisis like these, and to advocate for hazard pay for the hardworking heroes on the front lines and recruitment incentives for new staff as we move forward.

In a time of anger and uncertainty against our law enforcement, I had the pleasure of having Majority Leader Crystal Peoples-Stokes come to the area to learn more about our Academy at MVCC and speak with some of our community's law enforcement officials and recruits.

The Mohawk Valley is home to countless, remarkable law enforcement officers who show up and ensure our families safety. Touring the Police Academy provided a platform for us to reconfirm the important role law enforcement provides, while providing insight into their training process and the myriad of subjects our officers undergo to better serve our community.





I participated in several food drives to ensure families received the help the deserved as hundred of residents worried about their employment.

I worked with my fellow legislators in the Mohawk Valley Nine to pull out all the stops to make sure we keep the home of Remington Arms in Ilion. I marched beside the countless workers who were unjustly laid off without pay.

I delivered PPE to community centers as they prepared to open.

I reached out to our elderly community members and created a Words of Wisdom series in hopes of providing people with a sense of hope https://nyassembly.gov/mem/Marianne-Buttenschon/story/92152

I partnered with local fire department representatives to host Stop the Bleed courses, which aimed to train bystanders how to help in a bleeding emergency before first responders arrive at the scene.

When the demand for blood increased to historic levels, I partnered with the Red Cross and held blood drives across the Mohawk Valley to bring our blood banks back to pre-pandemic levels.





During the holidays, I partnered with CNY Veteran's Outreach Center to make certain our veterans received a complete holiday meal.

In lieu of cookouts and parties, I created a virtual tour of the many veteran monuments in the Mohawk Valley for everyone to watch to express our gratitude for our heroes over Memorial Day. https://nyassembly.gov/mem/Marianne-Buttenschon

I also helped plant several flags along the Memorial Parkway during this year's Flags for all Heroes 2020.
