




Assemblywoman Donna Lupardo 2022 CONSTITUENT SURVEY RESULTS


1. Do you support allowing individuals to register to vote up to and including on Election Day?



Yes: 52.2%
No: 42.4%
UNDECIDED: 5.4%

The Assembly and Senate passed legislation I supported, which would allow individuals to register to vote up to 10 days prior to any upcoming primary, general or special election. This is the minimum currently permitted by the NYS Constitution without a constitutional amendment. When the Governor signs the bill, it will go into effect January 1st, 2023.


3. While convictions for serious sex offenses, all violent crimes, and class A felonies would remain ineligible, would you support the sealing of an individual's past record after they have served their sentence?



YES: 34.3%
NO: 47.0%
UNDECIDED: 18.7%

Legislation to seal certain convictions in an individual's criminal history after a set period of time failed to pass in the Assembly prior to the end of the legislative session. The "NYS Clean Slate Act" did, however, pass in the Senate.


2. Do you support legislation banning the use of natural gas utilities in all new building construction by requiring them to be 100% electric by 2027 or sooner?



YES: 24.7%
NO: 55.3%
UNDECIDED: 20.0%

During budget negotiations, a natural gas utility ban was discussed, however, an agreement could not be reached on when the requirement would go into effect. We also discussed the All-Electric Building Act, but an agreement could not be reached either. It's also important to note that this requirement would not apply to any current residential or commercial buildings.

4. Do you support increasing the bottle deposit on glass, metal & plastic containers from 5 cents to 10 cents to better incentivize recycling efforts?



YES: 50.4%
NO: 43.0%
UNDECIDED: 6.6%


An increase on bottle deposits and other proposals to increase recycling efforts were discussed during budget negotiations, however no changes to current bottle deposits were included in the final budget. Legislation on this topic did not pass either.


5. Do you support allowing mentally competent, terminally ill patients to request their doctor prescribe medication for the purpose of hastening the end of their life?



YES: 65.5%
NO: 23.2%
UNDECIDED: 14.2%

The “Compassionate Care Act” failed to receive a vote in the Assembly or Senate prior to the end of the legislative session. However, support is steadily increasing for this measure.


7. Do you support allowing distilleries and other alcoholic beverage producers to directly ship products to consumers through the mail as wineries are currently permitted to do?



YES: 60.8%
NO: 29.2%
UNDECIDED: 10.0%

Two pieces of legislation to allow for the direct shipment of spirits and ciders did not receive a vote in the Assembly or Senate this year. However, a separate measure to permit restaurants to sell alcoholic beverages to go was included in the final budget.


6. Do you support a statewide Good Cause Eviction statute which would establish a tenant’s right to an automatic lease renewal in most cases unless a landlord has good cause to evict?



YES: 35.6%
NO: 43.1%
UNDECIDED: 21.3%

“Good Cause Eviction” legislation did not receive a vote in either the Assembly or Senate this year. Some municipalities have enacted their own “Good Cause Eviction” statutes while others have voted against proposals. I’m sure this issue will be revisited next year.

8. Do you support a moratorium on cryptocurrency mining operations which are being criticized due to their environmental impacts and high energy usage?



YES: 50.2%
NO: 19.8%
UNDECIDED: 30.0%

A bill I supported to establish a moratorium on cryptocurrency mining in former power plants until a comprehensive environmental impact study is conducted was passed by both houses of the legislature.

9. What do you think should be the Legislature’s top priority in 2022?

As in the past, many respondents to this year’s survey were concerned about taxes and would also like to see continued efforts to bring new economic development and jobs to our area. We also received an overwhelming number of responses concerned with healthcare, infrastructure funding, the environment, and workforce development. While substantial resources were allocated to the Southern Tier for many of these priorities during the budget, I will continue to advocate for our fair share.
