Dear Neighbors,

It was wonderful to reconnect with the District last week before returning to Albany for the final additional days of session. I was grateful to have the opportunity to attend district events and to address important local issues such as NYSEG billing, which I will discuss further below.





Last Thursday I held a press conference with support from local advocacy groups and community leaders stating our opposition to proposed NYSEG rate increases. These delivery rate hikes will compound over 3 years for total increases of 62% for electric and 17.8% for gas. I joined community organizations, businesses, and individuals calling for the Governor to reject these proposed increases that are coming at a time when many are struggling to cover their basic living expenses and stay in their homes. Meanwhile, NYSEG has been seeing record profits while their ratepayers have been experiencing ongoing service and billing issues.


I encourage all of my constituents who are concerned about this rate hike to leave a comment with the Department of Public Service (DPS) as well as a comment to the Governor's office. Your voice and experiences are extremely important to this discussion.

If you have had or are currently experiencing service or billing problems with NYSEG, there are several steps you can take:

- 1. Call NYSEG Customer Service at 1-800-572-1111 to try and get it resolved.
- 2. If that is not effective, you can file an official complaint with DPS
- 3. You are also requested to <u>file comments about billing problems</u> in the Billing Investigations Docket
- 4. If you are threatened with termination of service and have a dispute with the utility, call the Public Service Commission (PSC) hotline at 1-800-342-3355. ## New Bills to Track

Last week, four of my new prime bills were printed:

### **A7805** Co-Occurring Disorder Education

Co-occurring disorder (COD) is the simultaneous suffering from mental illness and a comorbid substance use disorder, a phenomenon which has unfortunately been on the rise. This bill will require junior and senior high

schools to include co-occurring disorders in their health education curricula. This will help to provide young people who can be more at risk of CODs with the information and resources they need to recognize, prevent, and seek treatment for these issues.

#### **A7808** New York State Bird Safe Buildings Act

This bill would reduce bird mortality by incorporating various bird safety features and strategies into the design and maintenance of state buildings.

#### **A7811** Journalism Usage Fees

This bill would create a process for local news publishers to be compensated for their work that is used on social media platforms.

#### A7823 Care for Adult Malpractice Victims Injured at Birth Act

This bill will add adult day programs, sheltered workshops, and care coordination services to the health costs covered by the medical indemnity fund (MIF).
