Important LGBTQIA+ Bills Signed into Law

As Pride Month draws to a close, I am delighted to share that two of my bills that passed in this legislative session were signed into law: <u>A4903</u>, which ensures LGBTQIA+ individuals will receive substance use treatment in accordance with their gender identity, and <u>A1142</u>, which requires the use of gender-neutral terms in law.



### **Digihost Air Permit Denial Press Conference**

Last week I spoke out against the issuing of an air permit from the Department of Environmental Conservation to Digihost Technology, a bitcoin data mining company in a press conference hosted by EarthJustice.

Bitcoin mining is an incredibly energy-intensive industry, and New York state must not issue these types of permits if it is going to keep its commitment to the Climate Leadership and Community Protection Act (CLCPA) and state climate goals. Data mining activity releases an estimate of 300,000 metric tons of greenhouse gasses into the atmosphere per year and causes a significant increase in noise pollution and the pollution of our state's precious freshwater. We cannot as a state allow companies to profit from the irresponsible exploitation and degradation of our natural resources.



## Community Resources

### **Preparing to Travel Abroad?**

My office has recently heard from several constituents regarding passport expiration dates and travel requirements, and I want to share some important information that anyone preparing for international travel should be aware of.

Passports issued to those **16 or older** are valid for **10 years**. For those **younger than 16** when issued, they are valid for **5 years**.

Some countries require that a passport be valid for at least **six months beyond the dates of your travel**, so please look up your destination's requirements well in advance of your trip!
