10th Anniversary of September 11

In memory of our fellow citizens who lost their lives, Assemblyman Magnarelli joined City of Syracuse Firefighters and Syracuse Police Officers in commemorating the 10th Anniversary of the September 11 terrorist attacks. The ceremony was held at the Most Holy Rosary School.

William & Mognaulli Lakeside Fire Department **Rescue Vehicle**

Members of the Lakeside Fire Department launched their new water rescue boat in August 2011. Members of the Fire Department joined Assemblyman Magnarelli in the 20 foot boat that will provide a much quicker response time and allow several divers in the department to perform rescue operations that before were impossible. Funds were secured by Assemblyman Magnarelli in 2007.





Landmark Theatre Stagehouse Expansion

Assemblyman Magnarelli helped secure \$6.5 million to modernize the back-stage areas such as an expanded stage, upgraded dressing rooms and increased electrical power capacity, in order to attract and book larger Broadway touring shows, concerts and celebrity performances.

Assemblyman Magnarelli toured the Landmark's expanded stage with Executive Director Denise DiRienzo and Aaron Walter, Project Manager from Hueber Breuer Construction Company, Inc.

Summer Reading Challenge in cooperation with Libraries and Schools

To encourage our children to read more and become excited about reading, Assemblyman Magnarelli challenged students throughout the 120th District to achieve a goal of reading every day. Children were asked to read with their parents, with someone else or alone, for 40 or more days throughout the summer months. Once this goal was achieved and documented, the child earned a New York State Assembly Excellence in Reading Certificate.

At Salem Hyde Elementary, 110 students were recognized for their reading. Students from Solvay Elementary and Middle School, Onondaga Road Elementary, and Roberts Elementary also participated in the reading challenge.

Assemblyman Magnarelli toured the completed renovation of

Walberta Road in the Town of Geddes, having secured a grant for the complete reconstruction of its 200 block, covering an area approximately 910 feet long. Work also included the installation of drainage inlets, four drywells and storm sewer pipe. The road was excavated and rebuilt with a two-layer asphalt paving course.



A ssemblyman Magnarelli joined with Lt. Governor Robert Duffy and other dignitaries to pause and remember the events of 9/11 on the 10th Anniversary. Syracuse's M.O.S.T. was one of 30 locations across the state that hosted the "New York Remembers" exhibition. The exhibition featured historical artifacts from the collections of the State Museum and the National September 11 Memorial & Museum.

included: the Onondaga Lakeshore staging area, the LCP wetlands, the Geddes pipeline operations and the Camillus consolidation area.





5th Annual Lifesaver Blood Drive

t has become one of the biggest blood drives in Central New York and this year was no exception. The blood drive held July 19th at Gillette Road Middle School, sponsored by Assemblyman Magnarelli, exceeded our blood donation goal of 93. The American Red Cross



commended Assemblyman Magnarelli's leadership in sponsoring and promoting a summer blood drive when there is always a shortage of blood on hand. This year's drive produced: 100 donors scheduled, 97 donations collected and 19 first time donors resulting in 291 patients helped!

Alzheimer's Association Celebrates Activation of Missing Vulnerable Adult Alert

Assemblyman Magnarelli and Senator DeFrancisco presented the Alzheimer's Association a pen certificate signed by Governor Cuomo commemorating the Missing Vulnerable Adult Alert law. When enacted, the alert, similar to the Amber Alert, would use federal, state, and local resources to assist families in searching for mission adults who have cognitive impairments. The legislation also

requires law enforcement agencies to conduct training and education for all personnel regarding the recognition and management of missing vulnerable adults.





The 2011 CNY Volunteer Fair held at the Carousel Center Skydeck on September 20, sponsored by Assemblyman Magnarelli, was the most successful one to date. With over 50 non-profit and volunteer organizations available, this was a great opportunity for people to see how they can use their abilities to help meet the needs of our community.

The CNY Volunteer Fair is also a great opportunity for students looking to fulfill service requirements or searching for career connections.

Among those represented this year were hospitals, literacy advocacy sites, senior citizen centers, community centers, recreation/rehabilitation centers and organizations advocating for those with specific diseases, ailments or support services.

Legislation sponsored or supported by Assemblyman Magnarelli and signed into law during the 2011 session:

- Caps Property Taxes (A.8518) Caps property tax growth at 2% a year, unless the municipality votes to override
- Ethics Reform Legislation (A.8307) New ethics law requires greater financial disclosure for public officials, and lobbyists, creation of the new Joint Commission on Public Ethics, and increased penalties for violations.
- Land Banks Legislation (A.373-A) Allows municipalities to establish "Land Banks" for the purposes of redeveloping abandoned, tax delinquent or blighted properties.
- **Program Bill EFC Bonding Chapter 41** (A.6307) Extends for the 3 years the ability of municipalities to issue grid bonds or authorize installment loans to the NY State Environmental Facilities Corp. to obtain assistance from the Clean Water and Drinking Water Revolving Funds.
- **Program Bill DHCR Bonding Chapter 71** (A.6306) Continues the orderly flow of Private Activity Bonds for the development of affordable housing and other economic activity in New York.
- Missing Vulnerable Adults Alert Chapter 222 (A.676-B) Creates an 'Amber Alert' type system for adults with medical or mental illnesses who go missing
- Syracuse Airport Authority (A.2166-A) Creates the Syracuse Regional Airport Authority to manage Hancock International Airport.
- **Bioscience Curriculum Funding Chapter 467** (A.7156-A) Authorizes the Empire State Development Corp. to fund bioscience curriculum and workforce training, to educate individuals to work in bioscience based industries
- **PLLC Merger Bill** (A.678) When a PLLC and PC merge they can chose the appropriate corporate structure for the new company, instead of automatically becoming a PC.
- School Tax Payment Flex Bill (A.6719) Gives school districts flexibility in setting a first installment of a property tax payment lower than 50% for those who pay by installments.

2011 CNY Veterans Parade & Expo held at the NYS Fairgrounds on November 5th sponsored by Assemblyman Magnarelli

This year's parade was moved to the New York State Fairgrounds and an indoor venue Expo was added. The Expo highlighted military support organizations, and included a special award ceremony for soldiers and organizations.

Thousands of spectators watched 90 organizations put on an hour and a half long parade filled with performances, music, and local veterans from all conflicts since WWII. The Expo featured great displays of military and veterans' interests, and informational displays of organizations that help veterans and soldiers. A special performance by the West Point Drill Team was extremely well-received by the crowd.
