The Assembly Standing Committee on Agriculture oversees New York State's agriculture, food, animal protection, and other regulatory programs administered by the State Department of Agriculture and Markets. In the SFY 2018-2019 Department of Agriculture and Markets budget, the Legislature included approximately \$54 million for local assistance and \$115 million for State operations. Funding for capital projects, including the State fair, local fairs and companion animal shelters, totaled \$17 million. The purpose of this hearing is to examine the overall impact and implementation of the 2018-2019 budget, and assess the impact and effectiveness of New York's agricultural programs. This hearing will also examine the agricultural industry's economic significance to New York State and challenges that agricultural producers are facing in bringing their products to market.

Ten copies of any prepared testimony should be submitted at the hearing registration desk. The Committee would appreciate advance receipt of prepared statements.

In order to further publicize these hearings, please inform interested parties and organizations of the Committee's interest in hearing testimony from all relevant sources.
