SUBJECT: Review of Climate Change Expenditures by State Entities

<u>PURPOSE</u>: To examine the success of climate-change related expenditures

The State has access to a variety of funding intended to address climate change, ranging from funding in the Environmental Protection Fund (EPF) to the New York State Energy Research and Development Authority. In addition, the Climate Leadership and Community Protection Act (CLCPA) states that State agencies, authorities and entities "shall...invest or direct available and relevant programmatic resources in a manner designed to achieve a goal for disadvantaged communities to receive forty percent of overall benefits of spending on clean energy and energy efficiency programs, projects or investments in the areas of housing, workforce development, pollution reduction, low income energy assistance, energy, transportation and economic development."

The purpose of this hearing is to examine how agencies and authorities are using available climate-change funding, including whether the CLCPA allocation of forty percent for disadvantaged communities has been achieved.

Persons wishing to present pertinent testimony to the Committee at the above hearing should complete and return the enclosed reply form as soon as possible, <u>but no later than Wednesday November 24th</u>. It is important that the reply form be fully completed and returned so that persons may be notified in the event of emergency postponement or cancellation.

Oral testimony will be limited to five minutes' duration. In preparing the order of witnesses, the Committees will attempt to accommodate individual requests to speak at particular times in view of special circumstances. These requests should be made on the attached reply form or communicated to Committee staff as early as possible.

Ten copies of any prepared testimony should be submitted at the hearing registration desk. The Committees would appreciate advance receipt of prepared statements.

Attendees and participants at any legislative public hearing should be aware that these proceedings are video recorded. Their likenesses may be included in any video coverage shown on television or the internet.

In order to further publicize these hearings, please inform interested parties and organizations of the Committees' interest in hearing testimony from all sources.

In order to meet the needs of those who may have a disability, the Assembly, in accordance with its policy of non-discrimination on the basis of disability, as well as the 1990 Americans with Disabilities Act (ADA), has made its facilities and services available to all individuals with disabilities.
