**NOTICE OF PUBLIC HEARING**

**SUBJECT:** Status of Mandated Reporters of Child Abuse or Maltreatment in New York State

**PURPOSE:** To examine the range of mandated reporters, their effectiveness and impact on the child welfare system, potential biases, and how the system can be reformed.

New York State recognizes that certain professionals are specially equipped to fulfill the role of mandated reporter of child abuse or maltreatment. Mandated reporters are required to report suspected child abuse or maltreatment when, in their professional capacity, they are presented with reasonable cause to suspect child abuse or maltreatment. In New York State, more than four dozen designated professional titles are mandated by law to report reasonable suspicions of abuse to the State Central Registry (SCR). Following the receipt of a SCR hotline report, a Child Protective Services (CPS) investigation is opened, which can lead to state intervention, family disruption, and child separation.

A range of questions have been raised about the child welfare system, including analysis of the racial and ethnic disparities in CPS cases across the State. According to a study reported by the New England Review of Medicine in 2020, it was noted that Black families are more likely to be reported and investigated for child abuse and neglect, to have their cases substantiated, and to have their children removed from their custody or care. Further, by the time they reach 18 years old, 53% of Black children in the United States will have been subjected to at least one child protective services investigation compared with 28% of white children and 37% of all children. In 2019, according to the Office of Children and Family Services (OCFS), Black children were 3.7 times more likely to enter foster care than White children, representing 52% of children in foster care in New York, and in New York City specifically, the New York State Bar Association in 2020 found that although Black and Hispanic children comprise only 61.3% of the total NYC population, they constitute 87.8% of the children in investigations.

The committees seek to receive testimony from relevant stakeholders on the short and long-term impacts on children and families involved in the child welfare system; which demographics of children and families are impacted; and how effective are the state and local agencies in enforcing the various child welfare laws. Specifically, the committees wish to gather information regarding the effectiveness of the current mandated reporting system, as well as any recommendations that may be appropriate to help the State improve this process. Additionally, the committees seek to examine the extent to which racial and ethnic disparities exists in New York child welfare system and its effects on minority children and families across the State.

Oral testimony will be limited to five (5) minutes. In preparing the order of witnesses, the Committees will do their best to accommodate individual requests to speak at specific times in view of special circumstances, however these are not guaranteed. These requests should be made on the attached reply form or communicated to Committee staff no later than **Friday, February 10<sup>th</sup>, 2023**.

Please note that this public hearing will take place in New York City, and witnesses must attend in person if they wish to make a public statement. No virtual testimony option is available for this hearing.

Ten (10) copies of witnesses prepared testimony must be submitted at the hearing registration desk on the day of the hearing, or one copy may be submitted by email to the contact listed below no later than two (2) days prior to the hearing. The Committee would greatly appreciate advance receipt of prepared statements.

Attendees and participants at any legislative public hearing should be aware that these proceedings are video recorded. Their likenesses may be included in any video coverage shown on television or the internet.
