SUBJECT: Charitable Gaming

PURPOSE: To examine charitable gaming laws and their impact on charitable organizations across New York State.

Currently, New York State law allows for approved organizations to conduct charitable games as a means to fundraise. However, these laws have largely remained the same over the last several years. This hearing will examine the effectiveness of the current system regarding charitable gaming and discuss whether changes should be explored to further benefit charitable organizations. The Committee is interested in learning how approved organizations are maximizing opportunities to raise funds under current law, what potential changes should be considered, and what the future of charitable gaming looks like in the State of New York.

Persons wishing to present pertinent testimony to the Committee at the above hearing should complete and return the enclosed reply form as soon as possible. Oral testimony will be limited to 15 minutes' duration. Ten copies of any prepared testimony should be submitted at the hearing registration desk. The Committee would appreciate advance receipt of prepared statements.

In order to further publicize these hearings, please inform interested parties and organizations of the Committee's interest in hearing testimony from all sources.
