ORAL TESTIMONY WILL BE BY INVITATION ONLY

According to the most recent data available from the New York State Department of Transportation in a report entitled "New York State Carbon Reduction Strategy," the transportation sector in New York State contributed approximately 28% of the total greenhouse gas emissions in the State as of 2019. Of that amount, road transportation was responsible for more than half (59%). One of the approaches undertaken to help reduce transportation carbon emissions is to expand the adoption of zero emission vehicles (ZEVs), which requires the construction of necessary charging infrastructure on the State's roadways. This hearing is intended to provide the Committees with information on these efforts, including the current status, type, and availability of ZEV public charging infrastructure along State highways and the Thruway for light, medium, and heavy-duty vehicles, the continuing plans of the New York State Department of Transportation (DOT), the Thruway Authority, the New York State Energy Research and Development Authority (NYSERDA), and the New York Power Authority (NYPA) to further build out this infrastructure on State highways and the Thruway, and any resulting implications for electric grid capacity.

Persons invited to present pertinent testimony to the Committees at the above hearing should complete and return the enclosed reply form as soon as possible. It is important that the reply form be fully completed and returned so that persons may be notified in the event of emergency postponement or cancellation.

Oral testimony will be limited to ten minutes' duration. In preparing the order of witnesses, the Committees will attempt to accommodate individual requests to speak at particular times in view of special circumstances. These requests should be made on the attached reply form or communicated to Committee staff as early as possible.

Ten copies of any prepared testimony should be submitted at the hearing registration desk. The Committees would appreciate advance receipt of prepared statements.

Attendees and participants at any legislative public hearing should be aware that these proceedings are video recorded. Their likenesses may be included in any video coverage shown on television or the internet.

In order to further publicize these hearings, please inform interested parties and organizations of the Committees' interest in hearing testimony from all sources.
